

Table title: Table 1: Year-on-year percentage changes in the indices of industrial production by industry group and selected component industry(2000 = 100)

1. Percentage change of the revised index of industrial production classified to the food, beverages and tobacco industry in the first quarter of 2006 compared with the first quarter of 2005 was +5.8%.
1. Percentage change of the provisional index of industrial production classified to the food, beverages and tobacco industry in the second quarter of 2006 compared with the second quarter of 2005 was +4.7%.
2. Percentage change of the revised index of industrial production classified to the wearing apparel (except footwear) industry in the first quarter of 2006 compared with the first quarter of 2005 was +35.8%.
2. Percentage change of the provisional index of industrial production classified to the wearing apparel (except footwear) industry in the second quarter of 2006 compared with the second quarter of 2005 was +22.1%.
3. Percentage change of the revised index of industrial production classified to the textiles (including knitting) industry in the first quarter of 2006 compared with the first quarter of 2005 was +11.4%.
3. Percentage change of the provisional index of industrial production classified to the textiles (including knitting) industry in the second quarter of 2006 compared with the second quarter of 2005 was +16.7%.
4. Percentage change of the revised index of industrial production classified to the paper products and printing industry in the first quarter of 2006 compared with the first quarter of 2005 was +3.4%.
4. Percentage change of the provisional index of industrial production classified to the paper products and printing industry in the second quarter of 2006 compared with the second quarter of 2005 was +2.8%.
5. Percentage change of the revised index of industrial production classified to the chemical, rubber, plastic and non-metallic mineral products industry in the first quarter of 2006 compared with the first quarter of 2005 was +10.1%.
5. Percentage change of the provisional index of industrial production classified to the chemical, rubber, plastic and non-metallic mineral products industry in the second quarter of 2006 compared with the second quarter of 2005 was -0.3%.
5. Within the chemical, rubber, plastic and non-metallic mineral products industry, the percentage change of the revised index of industrial production classified to the plastic products industry in the first quarter of 2006 compared with the first quarter of 2005 was +3.9%.

5. Within the chemical, rubber, plastic and non-metallic mineral products industry, the percentage change of the provisional index of industrial production classified to the plastic products industry in the second quarter of 2006 compared with the second quarter of 2005 was +2.3%.

6. Percentage change of the revised index of industrial production classified to the basic metals and fabricated metal products industry in the first quarter of 2006 compared with the first quarter of 2005 was -0.5%.

6. Percentage change of the provisional index of industrial production classified to the basic metals and fabricated metal products industry in the second quarter of 2006 compared with the second quarter of 2005 was +2.3%.

6. Within the basic metals and fabricated metal products industry, the percentage change of the revised index of industrial production classified to the fabricated metal products (except machinery and equipment) industry in the first quarter of 2006 compared with the first quarter of 2005 was -0.6%.

6. Within the basic metals and fabricated metal products industry, the percentage change of the provisional index of industrial production classified to the fabricated metal products (except machinery and equipment) industry in the second quarter of 2006 compared with the second quarter of 2005 was +5.1%.

7. Percentage change of the revised index of industrial production classified to the electrical and electronic products, machinery, professional equipment and optical goods industry in the first quarter of 2006 compared with the first quarter of 2005 was +2.3%.

7. Percentage change of the provisional index of industrial production classified to the electrical and electronic products, machinery, professional equipment and optical goods industry in the second quarter of 2006 compared with the second quarter of 2005 was +0.5%.

7. Within the electrical and electronic products, machinery, professional equipment and optical goods industry, the percentage change of the revised index of industrial production classified to the consumer electrical and electronic products industry in the first quarter of 2006 compared with the first quarter of 2005 was +6.2%.

7. Within the electrical and electronic products, machinery, professional equipment and optical goods industry, the percentage change of the provisional index of industrial production classified to the consumer electrical and electronic products industry in the second quarter of 2006 compared with the second quarter of 2005 was +5.1%.

7. Within the electrical and electronic products, machinery, professional equipment and optical goods industry, the percentage change of the revised index of industrial production classified to the machinery, equipment, apparatus, parts and components industry in the first quarter of 2006 compared with the first quarter of 2005 was +2.2%.

7. Within the electrical and electronic products, machinery, professional equipment and optical goods industry, the percentage change of the provisional index of industrial production classified to the machinery, equipment, apparatus, parts and components industry in the second quarter of 2006 compared with the second quarter of 2005 was -0.1%.

8. Percentage change of the revised index of industrial production classified to the miscellaneous manufacturing industries in the first quarter of 2006 compared with the first quarter of 2005 was +0.7%.

8. Percentage change of the provisional index of industrial production classified to the miscellaneous manufacturing industries in the second quarter of 2006 compared with the second quarter of 2005 was +1.5%.

Percentage change of the revised index of industrial production for all manufacturing industries in the first quarter of 2006 compared with the first quarter of 2005 was +7.0%.

Percentage change of the provisional index of industrial production for all manufacturing industries in the second quarter of 2006 compared with the second quarter of 2005 was +5.3%.

1. Percentage change of the revised producer price index classified to the wearing apparel (except footwear) industry in the first quarter of 2006 compared with the first quarter of 2005 was +0.9%.
1. Percentage change of the provisional producer price index classified to the wearing apparel (except footwear) industry in the second quarter of 2006 compared with the second quarter of 2005 was +0.2%.
2. Percentage change of the revised producer price index classified to the textiles (including knitting) industry in the first quarter of 2006 compared with the first quarter of 2005 was -0.4%.
2. Percentage change of the provisional producer price index classified to the textiles (including knitting) industry in the second quarter of 2006 compared with the second quarter of 2005 was -0.2%.
3. Percentage change of the revised producer price index classified to the paper products and printing industry in the first quarter of 2006 compared with the first quarter of 2005 was within +/-0.05%.
3. Percentage change of the provisional producer price index classified to the paper products and printing industry in the second quarter of 2006 compared with the second quarter of 2005 was +1.1%.
4. Percentage change of the revised producer price index classified to the plastic products industry in the first quarter of 2006 compared with the first quarter of 2005 was -1.6%.
4. Percentage change of the provisional producer price index classified to the plastic products industry in the second quarter of 2006 compared with the second quarter of 2005 was +5.8%.
5. Percentage change of the revised producer price index classified to the fabricated metal products (except machinery and equipment) industry in the first quarter of 2006 compared with the first quarter of 2005 was +9.5%.
5. Percentage change of the provisional producer price index classified to the fabricated metal products (except machinery and equipment) industry in the second quarter of 2006 compared with the second quarter of 2005 was +9.3%.
6. Percentage change of the revised producer price index classified to the consumer electrical and electronic products industry in the first quarter of 2006 compared with the first quarter of 2005 was +0.2%.
6. Percentage change of the provisional producer price index classified to the consumer electrical and electronic products industry in the second quarter of 2006 compared with the second quarter of

2005 was +2.8%.

7. Percentage change of the revised producer price index classified to the machinery, equipment, apparatus, parts and components industry in the first quarter of 2006 compared with the first quarter of 2005 was -11.5%.

7. Percentage change of the provisional producer price index classified to the machinery, equipment, apparatus, parts and components industry in the second quarter of 2006 compared with the second quarter of 2005 was -9.4%.

8. Percentage change of the revised producer price index classified to the other manufacturing industries in the first quarter of 2006 compared with the first quarter of 2005 was +7.8%.

8. Percentage change of the provisional producer price index classified to the other manufacturing industries in the second quarter of 2006 compared with the second quarter of 2005 was +7.6%.

Percentage change of the revised producer price index for all manufacturing industries in the first quarter of 2006 compared with the first quarter of 2005 was +2.0%.

Percentage change of the provisional producer price index for all manufacturing industries in the second quarter of 2006 compared with the second quarter of 2005 was +2.5%.
