Number of establishments of land passenger transport industry was 14 657. Its year-on-year percentage change was -1.9%.

Number of persons engaged of land passenger transport industry was 59 485. Its year-on-year percentage change was +1.5%.

Business receipts and other income of land passenger transport industry was HK\$ 33,997 million. Its year-on-year percentage change was +4.4%.

Compensation of employees of land passenger transport industry was HK\$ 9,246 million. Its year-on-year percentage change was +1.6%.

Operating expenses of land passenger transport industry was HK\$ 15,770 million. Its year-on-year percentage change was +8.7%.
