Number of establishments of food, beverages and tobacco industry was 814. Its year-on-year percentage change was +25.0%.  
 Number of persons engaged of food, beverages and tobacco industry was 24 168. Its year-on-year percentage change was -6.2%.  
 Compensation of employees of food, beverages and tobacco industry was HK\$4,096 million. Its year-on-year percentage change was +15.9%.  
 Consumption of materials, supplies & industrial work/services of food, beverages and tobacco industry was HK\$10,011 million. Its year-on-year percentage change was +13.2%.  
 Other expenses of food, beverages and tobacco industry was HK\$2,958 million. Its year-on-year percentage change was +19.0%.  
 Gross surplus of food, beverages and tobacco industry was HK\$3,218 million. Its year-on-year percentage change was +10.5%.

 Consumption of materials, supplies & industrial work/services of all manufacturing industries was HK\$106,907 million. Its year-on-year percentage change was +9.4%.  
 Other expenses of all manufacturing industries was HK\$17,633 million. Its year-on-year percentage change was -7.0%.  
 Gross surplus of all manufacturing industries was HK\$20,137 million. Its year-on-year percentage change was

+0.7%.

Gross output of all manufacturing industries was HK\$171,305 million. Its year-on-year percentage change was +5.0%.
