The value of domestic exports classified to the food industry in 2007 was HK\$1483.4 million.

The value of domestic exports classified to the food industry in 2006 was HK\$1400.9 million.

Value change of domestic exports classified to the food industry was HK\$+82.5 million.

Percentage change of domestic exports classified to the food industry was +5.9%.

The value of domestic exports classified to the beverages industry in 2007 was HK\$377.2 million.

The value of domestic exports classified to the beverages industry in 2006 was HK\$370.5 million.

Value change of domestic exports classified to the beverages industry was HK\$+6.7 million.

Percentage change of domestic exports classified to the beverages industry was +1.8%.

The value of domestic exports classified to the tobacco manufactures industry in 2007 was HK\$1873.5 million.

Value change of domestic exports classified to other manufacturing industries was HK\$+1272.2 million.

Percentage change of domestic exports classified to other manufacturing industries was +13.9%.

Total value of domestic exports in 2007 was HK\$ 107239.0 million.

Total value of domestic exports in 2006 was HK\$ 132508.2 million.

Value change of total domestic exports was HK\$ -25269.2 million.

Percentage change of total domestic exports was -19.1%.

Note 1 : There may be a slight discrepancy between the sum of individual items and the total as shown in the table owing to rounding. The percentage changes are calculated from unrounded figures.

Note 2 : The statistics in the above table are derived by re-grouping the merchandise domestic export items (except gold and specie) under the Standard International Trade Classification, Revision 3 according to the industries in which these items are normally produced. Owing to the changes in trade classification, the above statistics may not be strictly comparable with those published in earlier years.
