The Composite CPI covers 90% of households, which had an average monthly household expenditure of \$4000 to \$59999 in the same period.

As for the average monthly rate of change in the seasonally adjusted Composite CPI during the latest 3 months, it was 0.4% in March 2008. The corresponding rate of change in February was 0.5%.
