The Composite CPI covers 90% of households, which had an average monthly household expenditure of \$4000 to \$59999 in the same period.

of the CPI(A), CPI(B), and CPI(C) adjusted to the price level of 2007 are broadly equivalent to \$4100 to \$16100, \$16100 to \$28900 and \$28900 to \$63200 respectively, and that of the Composite CPI is broadly equivalent to \$4100 to \$63200.
