Value of total exports to the mainland of China for the 2008 Q1 is HK\$ 312,387 million.

2008 Q1 percentage change of value of total exports to the mainland of China compared with the 2007 Q1 is +11.1%.

Value of domestic exports to the mainland of China for the 2008 Q1 is HK\$ 8,330 million.

2008 Q1 percentage change of value of domestic exports to the mainland of China compared with the 2007 Q1 is +0.8%.
