(3) Seasonally adjusted series may be revised as more data become available. For the volume index of total restaurant receipts, its seasonally adjusted series for the preceding three years is revised each year when the figures for the first quarter of the current year become available.

(4) Starting from the first quarter of 2008, seasonal adjustment of the volume index of total restaurant receipts is performed using the X-12 ARIMA method to replace the previous X-11 ARIMA method. Seasonally adjusted figures for earlier quarters have also been revised using the X-12 ARIMA method. The X-12 ARIMA method is an update to the X-11 ARIMA method with enhanced modelling and diagnostic capabilities. The X-12 ARIMA method has now been a standard method used by statistical offices for performing seasonal adjustment of statistical series in many countries/territories.
