The Composite CPI covers 90% of households, which had an average monthly household expenditure of \$4000 to \$59999 in the same period.

Taking into account the impact of price changes since the base period, the monthly household expenditure ranges

of the CPI(A), CPI(B), and CPI(C) adjusted to the price level of 2008 are broadly equivalent to \$4300 to \$16800, \$16800 to \$30200 and \$30200 to \$66100 respectively, and that of the Composite CPI is broadly equivalent to \$4300 to \$66100.
