

Table title: Table 1: Year-on-year percentage changes in the indices of industrial production by industry group (Year 2008 = 100)

1. Percentage change of the revised index of industrial production classified to the food, beverages and tobacco industry in the first quarter of 2009 compared with the first quarter of 2008 was -5.3%.

1. Percentage change of the provisional index of industrial production classified to the food, beverages and tobacco industry in the second quarter of 2009 compared with the second quarter of 2008 was -0.5%.

2. Percentage change of the revised index of industrial production classified to the textiles industry in the first quarter of 2009 compared with the first quarter of 2008 was -22.6%.

2. Percentage change of the provisional index of industrial production classified to the textiles industry in the second quarter of 2009 compared with the second quarter of 2008 was -23.6%.

3. Percentage change of the revised index of industrial production classified to the wearing apparel industry in the first quarter of 2009 compared with the first quarter of 2008 was -31.1%.

3. Percentage change of the provisional index of industrial production classified to the wearing apparel industry in the second quarter of 2009 compared with the second quarter of 2008 was -30.3%.

4. Percentage change of the revised index of industrial production classified to the paper products, printing and reproduction of recorded media industry in the first quarter of 2009 compared with the first quarter of 2008 was -8.2%.

4. Percentage change of the provisional index of industrial production classified to the paper products, printing and reproduction of recorded media industry in the second quarter of 2009 compared with the second quarter of 2008 was -10.1%.

5. Percentage change of the revised index of industrial production classified to the metal, computer, electronic and optical products, machinery and equipment industry in the first quarter of 2009 compared with the first quarter of 2008 was -13.1%.

5. Percentage change of the provisional index of industrial production classified to the metal, computer, electronic and optical products, machinery and equipment industry in the second quarter of 2009 compared with the second quarter of 2008 was -12.9%.

6. Percentage change of the revised index of industrial production classified to the miscellaneous manufacturing industries in the first quarter of 2009 compared with the first quarter of 2008 was -8.3%.

6. Percentage change of the provisional index of industrial production classified to the miscellaneous manufacturing industries in the second quarter of 2009 compared with the second quarter of 2008 was -3.6%.

Percentage change of the revised index of industrial production for manufacturing sector in the first quarter of 2009 compared with the first quarter of 2008 was -10.1%.

Percentage change of the provisional index of industrial production for manufacturing sector in the second quarter of 2009 compared with the second quarter of 2008 was -9.5%.

1. Percentage change of the revised producer price index classified to the food, beverages and tobacco industry in the first quarter of 2009 compared with the first quarter of 2008 was +6.3%.

1. Percentage change of the provisional producer price index classified to the food, beverages and tobacco industry in the second quarter of 2009 compared with the second quarter of 2008 was +2.7%.

2. Percentage change of the revised producer price index classified to the textiles industry in the first quarter of 2009 compared with the first quarter of 2008 was +0.3%.

2. Percentage change of the provisional producer price index classified to the textiles industry in the second quarter of 2009 compared with the second quarter of 2008 was -0.5%.

3. Percentage change of the revised producer price index classified to the wearing apparel industry in the first quarter of 2009 compared with the first quarter of 2008 was -0.8%.

3. Percentage change of the provisional producer price index classified to the wearing apparel industry in the second quarter of 2009 compared with the second quarter of 2008 was -1.4%.

4. Percentage change of the revised producer price index classified to the paper products, printing and reproduction of recorded media industry in the first quarter of 2009 compared with the first quarter of 2008 was -2.5%.

4. Percentage change of the provisional producer price index classified to the paper products, printing and reproduction of recorded media industry in the second quarter of 2009 compared with the second quarter of 2008 was -1.3%.

5. Percentage change of the revised producer price index classified to the metal, computer, electronic and optical products, machinery and equipment industry in the first quarter of 2009 compared with the first quarter of 2008 was -4.4%.

5. Percentage change of the provisional producer price index classified to the metal, computer, electronic and optical products, machinery and equipment industry in the second quarter of 2009 compared with the second quarter of 2008 was -7.8%.

6. Percentage change of the revised producer price index classified to the miscellaneous manufacturing industries in the first quarter of 2009 compared with the first quarter of 2008 was -1.6%.

6. Percentage change of the provisional producer price index classified to the miscellaneous manufacturing industries in the second quarter of 2009 compared with the second quarter of 2008 was -2.3%.

Percentage change of the revised producer price index for manufacturing sector in the first quarter of 2009 compared with the first quarter of 2008 was -1.4%.

Percentage change of the provisional producer price index for manufacturing sector in the second quarter of 2009 compared with the second quarter of 2008 was -2.9%.
