

Table title : Table 1 Views on Expected Changes in Business Situation, Volume of Business/Output, Number of Persons Engaged and Selling Price/Service Charge in Q4 2009 as compared with Q3 2009

For the manufacturing sector, 31% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 41% expected it to remain the same and 28% expected it to be worse. Percentage of respondents expecting being better in business situation was more than that expecting being worse by 3 percentage points.

For the manufacturing sector, 25% of respondents expected the volume of production to increase in Q4 2009 as compared with Q3 2009; 42% expected it to remain the same and 33% expected it to decrease. Percentage of respondents expecting an increase in volume of production was less than that expecting a decrease by 8 percentage points.

For the manufacturing sector, 4% of respondents expected the number of persons engaged to increase in Q4 2009 as compared with Q3 2009; 87% expected it to remain the same and 9% expected it to decrease. Percentage of respondents expecting an increase in number of persons engaged was less than that expecting a decrease by 5 percentage points.

For the manufacturing sector, 18% of respondents expected the selling price to increase in Q4 2009 as compared with Q3 2009; 68% expected it to remain the same and 13% expected it to decline. Percentage of respondents expecting an increase in selling price was more than that expecting a decline by 5 percentage points.

For the construction sector, 15% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 48% expected it to remain the same and 38% expected it to be worse. Percentage of respondents expecting being better in business situation was less than that expecting being worse by 23 percentage points.

For the construction sector, 31% of respondents expected the volume of construction output to increase in Q4 2009 as compared with Q3 2009; 49% expected it to remain the same and 20% expected it to decrease. Percentage of respondents expecting an increase in volume of construction output was more than that expecting a decrease by 11 percentage points.

For the construction sector, 15% of respondents expected the number of persons engaged to increase in Q4 2009 as compared with Q3 2009; 73% expected it to remain the same and 12% expected it to decrease. Percentage of respondents expecting an increase in number of persons engaged was more than that expecting a decrease by 3 percentage points.

For the construction sector, 2% of respondents expected the tender price to increase in Q4 2009 as compared with Q3 2009; 80% expected it to remain the same and 18% expected it to decline. Percentage of respondents expecting an increase in tender price was less than that expecting a decline by 16 percentage points.

For the import/export trade and wholesale sector, 27% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 47% expected it to remain the same and 26% expected it to be worse. Percentage of respondents expecting being better in business situation was more than that expecting being worse by 1 percentage point.

For the import/export trade and wholesale sector, 29% of respondents expected the volume of sales to increase in Q4 2009 as compared with Q3 2009; 47% expected it to remain the same and

24% expected it to decrease. Percentage of respondents expecting an increase in volume of sales was more than that expecting a decrease by 5 percentage points.

For the import/export trade and wholesale sector, 4% of respondents expected the number of persons engaged to increase in Q4 2009 as compared with Q3 2009; 79% expected it to remain the same and 17% expected it to decrease. Percentage of respondents expecting an increase in number of persons engaged was less than that expecting a decrease by 13 percentage points.

For the import/export trade and wholesale sector, 5% of respondents expected the selling price to increase in Q4 2009 as compared with Q3 2009; 80% expected it to remain the same and 15% expected it to decline. Percentage of respondents expecting an increase in selling price was less than that expecting a decline by 10 percentage points.

For the retail sector, 46% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 48% expected it to remain the same and 6% expected it to be worse. Percentage of respondents expecting being better in business situation was more than that expecting being worse by 40 percentage points.

For the retail sector, 51% of respondents expected the volume of sales to increase in Q4 2009 as compared with Q3 2009; 43% expected it to remain the same and 6% expected it to decrease. Percentage of respondents expecting an increase in volume of sales was more than that expecting a decrease by 45 percentage points.

For the retail sector, 25% of respondents expected the number of persons engaged to increase in Q4 2009 as compared with Q3 2009; 75% expected it to remain the same and 0% expected it to decrease. Percentage of respondents expecting an increase in number of persons engaged was more than that expecting a decrease by 25 percentage points.

For the retail sector, 19% of respondents expected the selling price to increase in Q4 2009 as compared with Q3 2009; 77% expected it to remain the same and 4% expected it to decline. Percentage of respondents expecting an increase in selling price was more than that expecting a decline by 15 percentage points.

For the accommodation and food services sector, 36% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 46% expected it to remain the same and 18% expected it to be worse. Percentage of respondents expecting being better in business situation was more than that expecting being worse by 18 percentage points.

For the accommodation and food services sector, 38% of respondents expected the volume of business to increase in Q4 2009 as compared with Q3 2009; 45% expected it to remain the same and 17% expected it to decrease. Percentage of respondents expecting an increase in volume of business was more than that expecting a decrease by 21 percentage points.

For the accommodation and food services sector, 8% of respondents expected the number of persons engaged to increase in Q4 2009 as compared with Q3 2009; 88% expected it to remain the same and 5% expected it to decrease. Percentage of respondents expecting an increase in number of persons engaged was more than that expecting a decrease by 3 percentage points.

For the accommodation and food services sector, 17% of respondents expected the price of food provided/charge for services rendered to increase in Q4 2009 as compared with Q3 2009; 81% expected it to remain the same and 2% expected it to decline. Percentage of respondents expecting

an increase in price of food provided/charge for services rendered was more than that expecting a decline by 15 percentage points.

For the transportation, storage and courier services sector, 17% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 64% expected it to remain the same and 19% expected it to be worse. Percentage of respondents expecting being better in business situation was less than that expecting being worse by 2 percentage points.

For the transportation, storage and courier services sector, 22% of respondents expected the volume of business to increase in Q4 2009 as compared with Q3 2009; 60% expected it to remain the same and 19% expected it to decrease. Percentage of respondents expecting an increase in volume of business was more than that expecting a decrease by 3 percentage points.

For the transportation, storage and courier services sector, 15% of respondents expected the number of persons engaged to increase in Q4 2009 as compared with Q3 2009; 77% expected it to remain the same and 8% expected it to decrease. Percentage of respondents expecting an increase in number of persons engaged was more than that expecting a decrease by 7 percentage points.

For the transportation, storage and courier services sector, 10% of respondents expected the charge for services rendered to increase in Q4 2009 as compared with Q3 2009; 89% expected it to remain the same and 0% expected it to decline. Percentage of respondents expecting an increase in charge for services rendered was more than that expecting a decline by 10 percentage points.

For the information and communications sector, 25% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 50% expected it to remain the same and 25% expected it to be worse. Percentage of respondents expecting being better in business situation was same as that expecting being worse by 0 percentage points.

For the information and communications sector, 25% of respondents expected the volume of business to increase in Q4 2009 as compared with Q3 2009; 50% expected it to remain the same and 25% expected it to decrease. Percentage of respondents expecting an increase in volume of business was same as that expecting a decrease by 0 percentage points.

For the information and communications sector, 2% of respondents expected the number of persons engaged to increase in Q4 2009 as compared with Q3 2009; 83% expected it to remain the same and 15% expected it to decrease. Percentage of respondents expecting an increase in number of persons engaged was less than that expecting a decrease by 13 percentage points.

For the information and communications sector, 13% of respondents expected the charge for services rendered to increase in Q4 2009 as compared with Q3 2009; 76% expected it to remain the same and 10% expected it to decline. Percentage of respondents expecting an increase in charge for services rendered was more than that expecting a decline by 3 percentage points.

For the financing and insurance sector, 41% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 53% expected it to remain the same and 6% expected it to be worse. Percentage of respondents expecting being better in business situation was more than that expecting being worse by 35 percentage points.

For the financing and insurance sector, 41% of respondents expected the volume of business to increase in Q4 2009 as compared with Q3 2009; 53% expected it to remain the same and 6% expected it to decrease. Percentage of respondents expecting an increase in volume of business was more than that expecting a decrease by 35 percentage points.

For the financing and insurance sector, 13% of respondents expected the number of persons engaged to increase in Q4 2009 as compared with Q3 2009; 81% expected it to remain the same and 6% expected it to decrease. Percentage of respondents expecting an increase in number of persons engaged was more than that expecting a decrease by 7 percentage points.

For the financing and insurance sector, 4% of respondents expected the premium rate/charge for services rendered to increase in Q4 2009 as compared with Q3 2009; 96% expected it to remain the same and 0% expected it to decline. Percentage of respondents expecting an increase in premium rate/charge for services rendered was more than that expecting a decline by 4 percentage points.

For the real estate sector, 25% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 68% expected it to remain the same and 7% expected it to be worse. Percentage of respondents expecting being better in business situation was more than that expecting being worse by 18 percentage points.

For the real estate sector, 28% of respondents expected the volume of business to increase in Q4 2009 as compared with Q3 2009; 60% expected it to remain the same and 11% expected it to decrease. Percentage of respondents expecting an increase in volume of business was more than that expecting a decrease by 17 percentage points.

For the real estate sector, 24% of respondents expected the number of persons engaged to increase in Q4 2009 as compared with Q3 2009; 65% expected it to remain the same and 12% expected it to decrease. Percentage of respondents expecting an increase in number of persons engaged was more than that expecting a decrease by 12 percentage points.

For the real estate sector, 24% of respondents expected the price of properties sold/management fee/commission rate to increase in Q4 2009 as compared with Q3 2009; 73% expected it to remain the same and 3% expected it to decline. Percentage of respondents expecting an increase in price of properties sold/management fee/commission rate was more than that expecting a decline by 21 percentage points.

For the professional and business services sector, 30% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 64% expected it to remain the same and 6% expected it to be worse. Percentage of respondents expecting being better in business situation was more than that expecting being worse by 24 percentage points.

For the professional and business services sector, 25% of respondents expected the volume of business to increase in Q4 2009 as compared with Q3 2009; 71% expected it to remain the same and 4% expected it to decrease. Percentage of respondents expecting an increase in volume of business was more than that expecting a decrease by 21 percentage points.

For the professional and business services sector, 15% of respondents expected the number of persons engaged to increase in Q4 2009 as compared with Q3 2009; 79% expected it to remain the same and 6% expected it to decrease. Percentage of respondents expecting an increase in

number of persons engaged was more than that expecting a decrease by 9 percentage points. For the professional and business services sector, 6% of respondents expected the charge for services rendered to increase in Q4 2009 as compared with Q3 2009; 94% expected it to remain the same and 0% expected it to decline. Percentage of respondents expecting an increase in charge for services rendered was more than that expecting a decline by 6 percentage points.

For all sectors taken together, 30% of respondents expected the business situation to be better in Q4 2009 as compared with Q3 2009; 53% expected it to remain the same and 17% expected it to be worse. Percentage of respondents expecting being better in business situation was more than that expecting being worse by 13 percentage points. These are weighted averages of sectoral figures.

Notes :

1. In collecting views on the quarter-to-quarter changes, if the variable in question may be subject to seasonal variations, respondents are asked to provide the expected changes after excluding the normal seasonal variations.
2. Responses on expected changes are expressed in terms of three categories. The percentages for the three response categories may not add up to 100% owing to rounding.
3. Survey results are generally presented as "net balance", i.e. the difference between the percentage of respondents choosing "up" over that choosing "down". The "net balance", with its appropriate sign, indicates the direction of expected change in the variable concerned. A positive sign indicates a likely upward trend while a negative sign, a likely downward trend.
4. Accommodation and food services mainly cover services rendered by hotels and restaurants.
5. Real estate sector covers real estate development, leasing, brokerage and agency, maintenance management, and other real estate services.
6. Professional and business services cover legal, accounting and other professional, scientific and technical services, and administrative and support services.
