Number of establishments of food, beverages and tobacco industry was 788. Its year-on-year percentage change was +2.9%.
Number of persons engaged of food, beverages and tobacco industry was 27 285. Its year-on-year percentage change was +2.9%.
Compensation of employees of food, beverages and tobacco industry was HK\$4,435 million. Its year-on-year percentage change was +15.1%.
Consumption of materials, supplies & industrial work/services of food, beverages and tobacco industry was HK\$12,875 million. Its year-on-year percentage change was +23.8%.
Other expenses of food, beverages and tobacco industry was HK\$3,045 million. Its year-on-year percentage change was -25.3%.
Gross surplus of food, beverages and tobacco industry was HK\$3,395 million. Its year-on-year percentage change was -21.0%.

 Gross surplus of other miscellaneous manufacturing industries was HK\$961 million. Its year-on-year percentage change was -23.6%.

 Compensation of employees of all manufacturing industries was HK\$25,146 million. Its year-on-year percentage change was +3.7%.
 Consumption of materials, supplies & industrial work/services of all manufacturing industries was HK\$116,439 million. Its year-on-year percentage change was +11.8%.
 Other expenses of all manufacturing industries was HK\$17,817 million. Its year-on-year percentage change was +7.0%.
 Gross surplus of all manufacturing industries was HK\$17,120 million. Its year-on-year percentage change was -11.4%.
 Gross output of all manufacturing industries was HK\$176,521 million. Its year-on-year percentage change

was +7.4%.

Value added of all manufacturing industries was HK\$42,194 million. Its year-on-year percentage change was -3.7%.
