- (2) Seasonal adjustment of the quarterly volume index of total restaurant receipts is performed using the X-12 ARIMA method, which has now become a standard method used by statistical offices for performing seasonal adjustment of statistical series in many countries/territories. For the monthly volume index of total restaurant receipts, seasonal adjustment will be performed when a longer data series is available in future.

Seasonally adjusted quarterly series may be revised as more data become available. For the quarterly volume index of total restaurant receipts, its seasonally adjusted series for the preceding three years is revised each year when the figures for the first quarter become available.
