Number of persons engaged of the manufacturing sector was 116 807. Its year-on-year percentage change was -5.0%.
Sales and other receipts of the manufacturing sector was HK\$168,128 million. Its year-on-year percentage change was -7.7%.
Compensation of employees of the manufacturing sector was HK\$19,721 million. Its year-on-year percentage change was -3.4%.
Operating expenses of the manufacturing sector was HK\$136,372 million. Its year-on-year percentage change was -8.1%.

Operating expenses include cost of materials and supplies, rent and rates for land and buildings, interest payments, payments for repair and maintenance services, transport and travelling expenses, communications expenses, insurance premiums, entertainment expenses, accounting fees and other expenses for business services, etc. Provision, gain/loss on disposal of fixed assets, bad debts, penalties, write-off, donations to charities, insurance excesses, depreciation, amortisation and taxation payments are not included in operating expenses.
