Percentage change of the provisional producer price index for manufacturing industries in the first quarter of 2011 compared with the first quarter of 2010 was +8.2%.

1. Percentage change of the revised producer price index classified to the food, beverages and tobacco industry in the fourth quarter of 2010 compared with the fourth quarter of 2009 was +2.2%.

1. Percentage change of the provisional producer price index classified to the food, beverages and tobacco industry in the first quarter of 2011 compared with the first quarter of 2010 was +4.2%.

2. Percentage change of the revised producer price index classified to the textiles industry in the fourth quarter of 2010 compared with the fourth quarter of 2009 was +6.5%.

2. Percentage change of the provisional producer price index classified to the textiles industry in the first quarter of 2011 compared with the first quarter of 2010 was +8.5%.
