Percentage change of the revised index of industrial production for manufacturing industries in the second quarter of 2011 compared with the second quarter of 2010 was +2.0%.

Percentage change of the provisional index of industrial production for manufacturing industries in the third quarter of 2011 compared with the third quarter of 2010 was +0.2%.

1. Percentage change of the revised index of industrial production classified to the food, beverages and tobacco industry in the second quarter of 2011 compared with the second quarter of 2010 was +9.8%.

1. Percentage change of the provisional index of industrial production classified to the food, beverages and tobacco industry in the third quarter of 2011 compared with the third quarter of 2010 was +5.7%.

Percentage change of the provisional producer price index for manufacturing industries in the third quarter of 2011 compared with the third quarter of 2010 was +9.6%.

1. Percentage change of the revised producer price index classified to the food, beverages and tobacco industry in the second quarter of 2011 compared with the second quarter of 2010 was +5.2%.

1. Percentage change of the provisional producer price index classified to the food, beverages and tobacco industry in the third quarter of 2011 compared with the third quarter of 2010 was +6.7%.

2. Percentage change of the revised producer price index classified to the textiles industry in the second quarter of 2011 compared with the second quarter of 2010 was +10.6%.
