Percentage change of the provisional index of industrial production for manufacturing industries in the first quarter of 2012 compared with the first quarter of 2011 was -1.6%.

1. Percentage change of the revised producer price index classified to the food, beverages and tobacco industry in the fourth quarter of 2011 compared with the fourth quarter of 2010 was +8.6%.

1. Percentage change of the provisional producer price index classified to the food, beverages and tobacco industry in the first quarter of 2012 compared with the first quarter of 2011 was +6.3%.
