Value of total exports to the mainland of China for the 2012 Q1 is HK\$ 418,464 million.

2012 Q1 percentage change of value of total exports to the mainland of China compared with the 2011 Q1 is -2.2%.

Value of domestic exports to the mainland of China for the 2012 Q1 is HK\$ 5,683 million.

2012 Q1 percentage change of value of domestic exports to the mainland of China compared with the 2011 Q1 is -28.8%.

Value of re-exports to the mainland of China for the 2012 Q1 is HK\$ 412,781 million.
