Percentage change of the revised index of industrial production for manufacturing industries in the first quarter of 2012 compared with the first quarter of 2011 was -1.6%.

Percentage change of the provisional index of industrial production for manufacturing industries in the second quarter of 2012 compared with the second quarter of 2011 was -2.9%.

1. Percentage change of the revised index of industrial production classified to the food, beverages and tobacco industry in the first quarter of 2012 compared with the first quarter of 2011 was +6.5%.

1. Percentage change of the provisional index of industrial production classified to the food, beverages and tobacco industry in the second quarter of 2012 compared with the second quarter of 2011 was +2.4%.

1. Percentage change of the revised producer price index classified to the food, beverages and tobacco industry in the first quarter of 2012 compared with the first quarter of 2011 was +6.4%.

1. Percentage change of the provisional producer price index classified to the food, beverages and tobacco industry in the second quarter of 2012 compared with the second quarter of 2011 was +4.1%.
