The quarter-to-quarter rate of change in business receipts indices of Computer and information technology services based on the seasonally adjusted series in Q4 2011 was $\pm 8.0\%$. The quarter-to-quarter rate of change in business receipts indices of Computer and information technology services based on the seasonally adjusted series in Q1 2012 was $\pm 1.0\%$. The quarter-to-quarter rate of change in business receipts indices of Computer and information technology services based on the seasonally adjusted series in Q2 2012 was $\pm 1.0\%$.

The quarter-to-quarter rate of change in business receipts indices of Computer and information technology services based on the seasonally adjusted series in O3 2012 was -5.3%.

- Note 1 The quarter-to-quarter rates of change in the business receipts indices of all service industries/domains based on the seasonally adjusted series in Q3 2012 and those of the tourism, convention and exhibition services domain in Q1 2012 and Q2 2012 were provisional figures.
- Note 2 Accommodation services cover hotels, guesthouses, boarding houses and other establishments providing short term accommodation.
- Note 3 The quarter-to-quarter rates of change in the BRIs of selected service industries/domains are derived based on the seasonally adjusted series to reflect the underlying trend of business receipts. These seasonally adjusted BRIs are compiled using the X-12 ARIMA method, which is a standard method applied in compiling seasonally adjusted statistical data series.
- Note 4 Seasonally adjusted series may be revised as more data become available. The seasonally adjusted BRIs of the retail industry will be revised annually when the figures for the fourth quarter of the current year are published, while those of the other service industries will be revised when the figures for the first quarter are published.
- Note 5 The BRIs of a few service industries including Financing (except banking), Financial markets and asset management, Asset management, Insurance and Real estate are found to have no clear seasonal patterns in the seasonal adjustment exercise. Seasonal adjustment is therefore not applied to the BRIs of these industries.
