The revised data series of GDP by economic activity backdated to 2000, together with the conceptual and methodological details of the technical revision, are presented in the *Special Report on Gross Domestic Product – September 2012* published by the C&SD.
 4. Accommodation services cover hotels, guesthouses, boarding houses and other establishments providing short term accommodation.
