Therefore, the adoption of "date of the Government receiving the notification of commencement of foundation works from the contractor" could better reflect the situation of works commencement of development projects than that of "date of receipt of the consent to Separately, "Not Available" in the above table means that as at end November 2012, the Buildings Department has not received the notification of commencement of foundation works from the contractor for the relevant development projects.									
Note 5 :	For a development project, the lot owner is required to complete the construction of the mimimum gross floor area specified in the lease conditions and obtain an occupation permit from the Building Authority within the Building Covenant period specified in the lease conditions. In other words, the "last date on which the developer must obtain the Occupation Permit" mentioned in the Question is the expiry date of the Building Covenant period specified in the lease.
