- Note 1 No new development for a domestic building or non-domestic building shall exceed a maximum domestic plot ratio of 5.0 or a maximum non-domestic plot ratio of 9.5.
- Note 2 No building shall result in the plot ratio in excess of 7.5 for a domestic building or 9.0 for a building that is partly domestic and partly non-domestic, or the plot ratio of the existing building, whichever is the greater. Under no circumstances shall the plot ratio for the domestic part of any building exceed 7.5.
- Note 3 On land designated 'Residential (Group A)', no new development for a domestic building or non-domestic building shall exceed a maximum domestic plot ratio of 5.0 or a maximum non-domestic plot ratio of 9.5.
  - On land designated 'Residential (Group E)', no building shall result in excess of a maximum total plot ratio of 5.0, or the plot ratio of the existing building, whichever is the greater.
- Note 4 Commercial Zoning: No building shall result in excess of a maximum gross floor area of  $17\ 725\ m^2$ .
  - Government, Institution or Community Zoning: Gross floor area not specified.
  - Residential (Group A) Zoning: No building shall result in the plot ratio in excess of 7.5 for a domestic building or 9.0 for a building that is partly domestic and partly non-domestic, or the plot ratio of the existing building, whichever is the greater. Under no circumstances shall the plot ratio for the domestic part of any building exceed 7.5.
