(1) 選定服務行業/界別的業務收益指數的按季變動百分率，是以經季節性調整數列計算，以辨識其業務收益的基本趨勢。經季節性調整數列是由「X-12 自迴歸-求和-移動平均」方法編製，該方法是用作編製經季節性調整的統計數列的標準方法。

(2) 經季節性調整的數列隨著資料更新而可能作出修訂。就零售業的業務收益指數而言，當每年發表第4季的數字時，有關的經季節性調整數列會作出按年修訂。而就其他服務行業的業務收益指數而言，有關修訂會於每年發表第1季的數字時作出。

(3) 少數服務行業的業務收益指數在季節性調整過程中並沒有明顯的季節性模式，因此這些行業的業務收益指數沒有作季節性調整。
