- Pote 1 Eligible outside bodies include schools registered under the Education Ordinance, non-governmental organisations receiving subventions from the Social Welfare Department, uniformed groups and youth organisations, member organisations of the Sports Federation & Olympic Committee of Hong Kong, China, sports organisations affiliated to national sports associations, district sports associations, the Hong Kong Schools Sports Federation, the New Territories Regional Sports Association, sports organisations supported by government departments and government departments.
- The current leases of these private sports clubs were granted before 2011. The requirement on Opening-up Scheme was not yet implemented at that time. Although these lessees are not required to draw up an Opening-up Scheme for HAB's approval, all of them have voluntarily opened up their sports facilities to eligible outside bodies. Their voluntary schemes are available on HAB's website.
