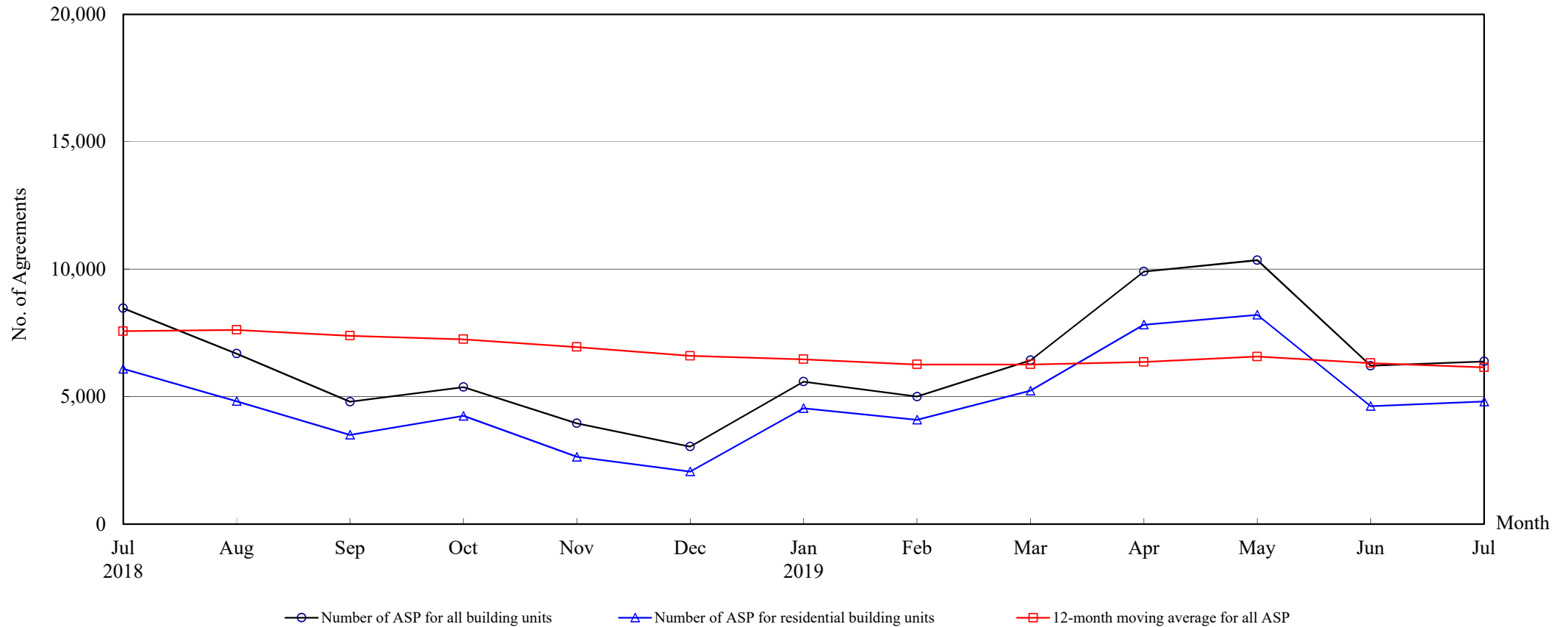

Chart showing the number of Sale and Purchase Agreements of building units from July 2018 to July 2019



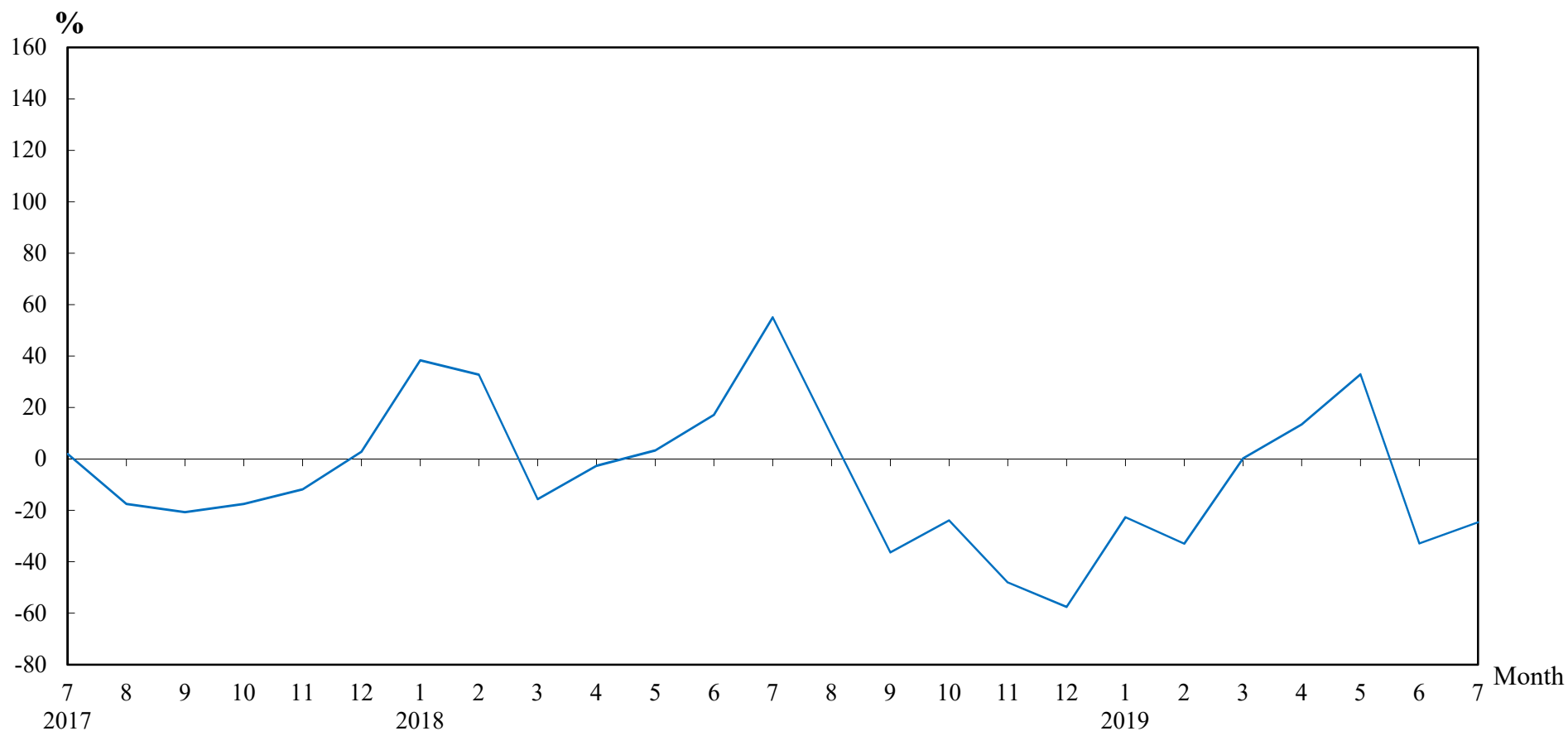
