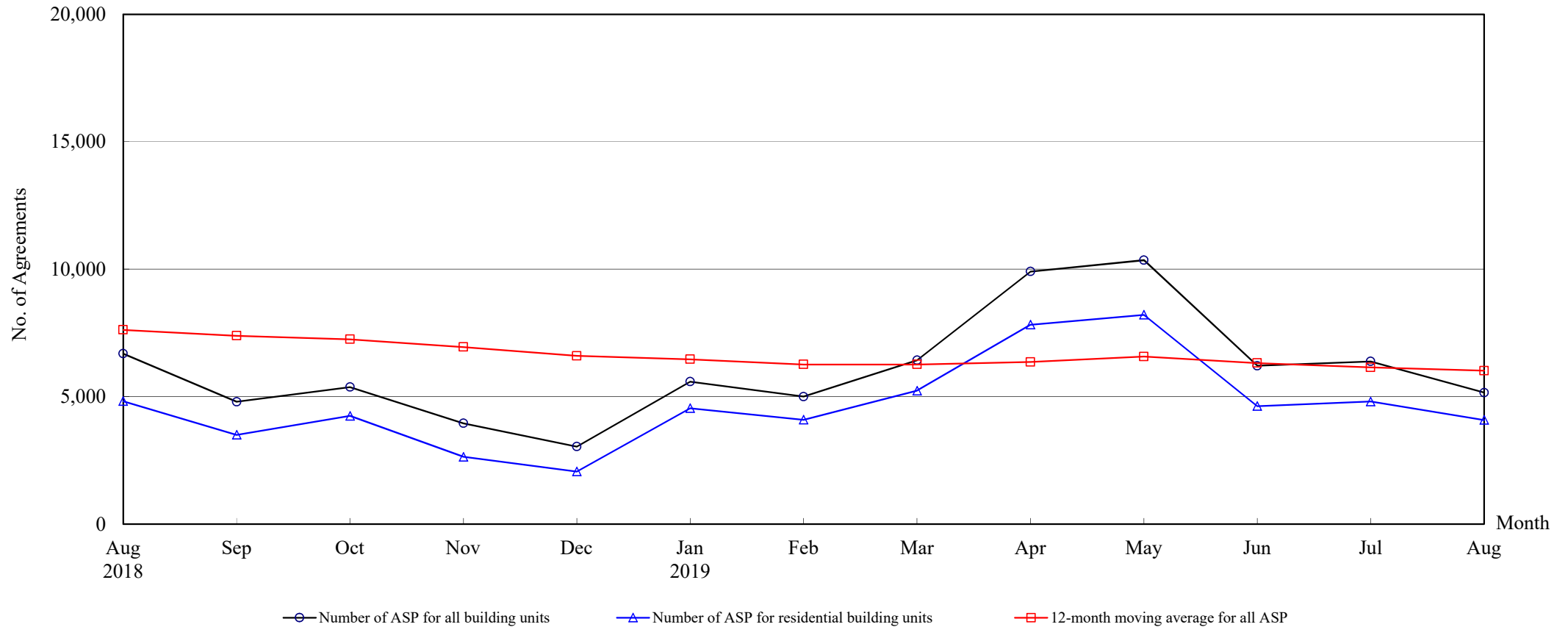

Chart showing the number of Sale and Purchase Agreements of building units from August 2018 to August 2019



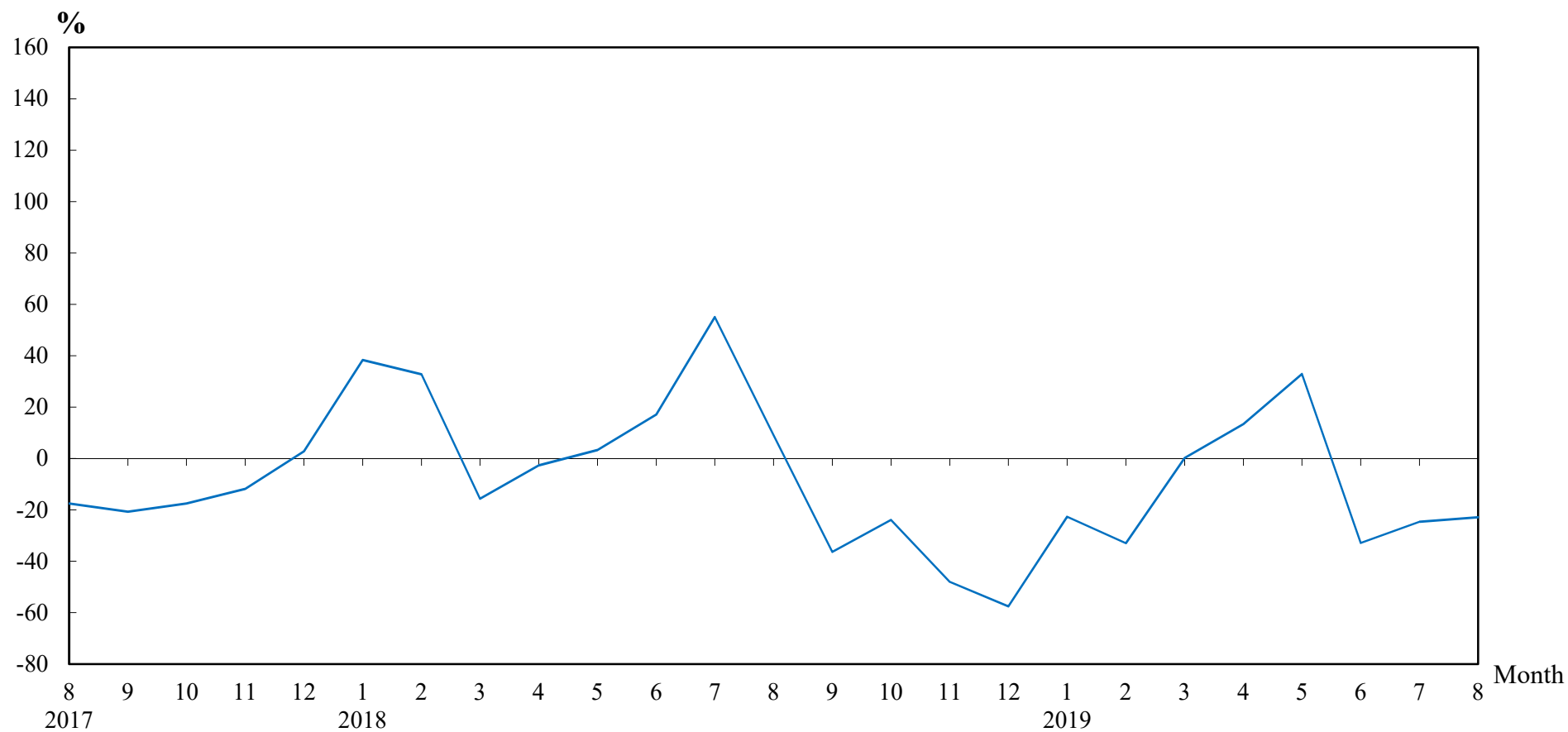
