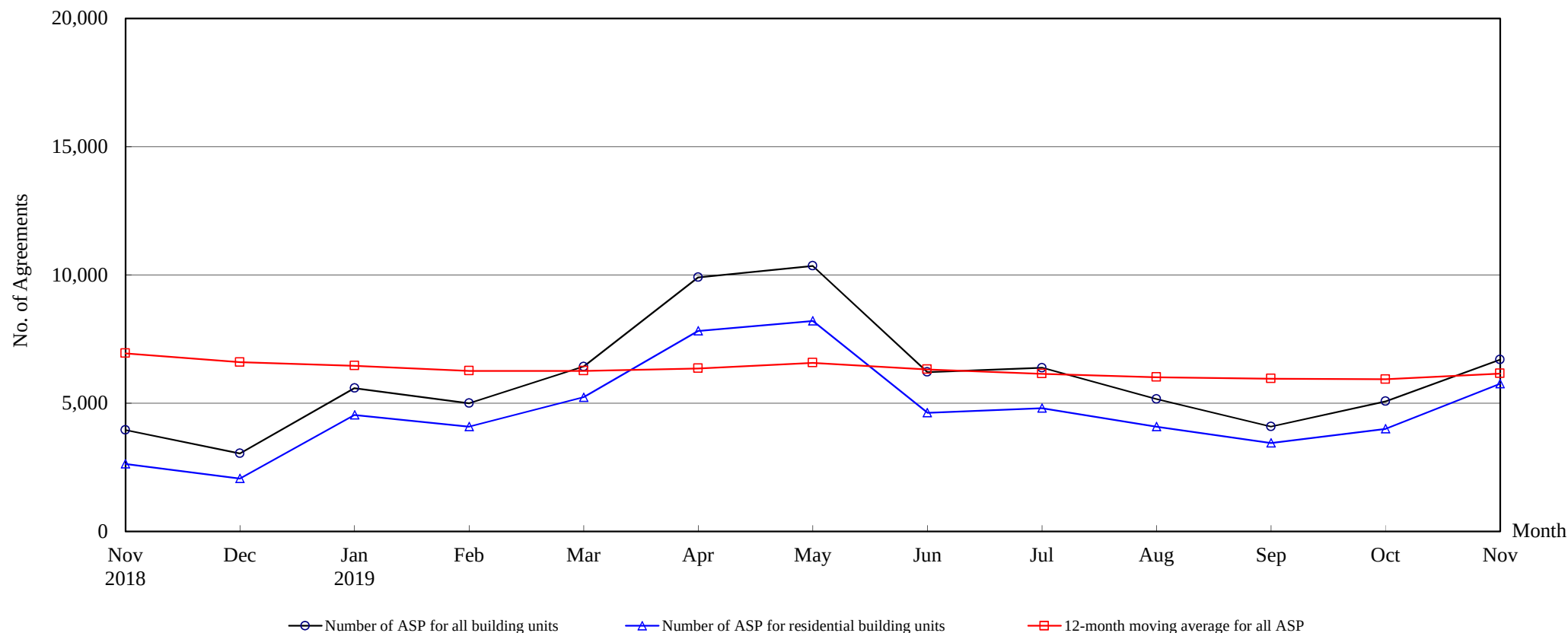

building units from November 2018 to November 2019



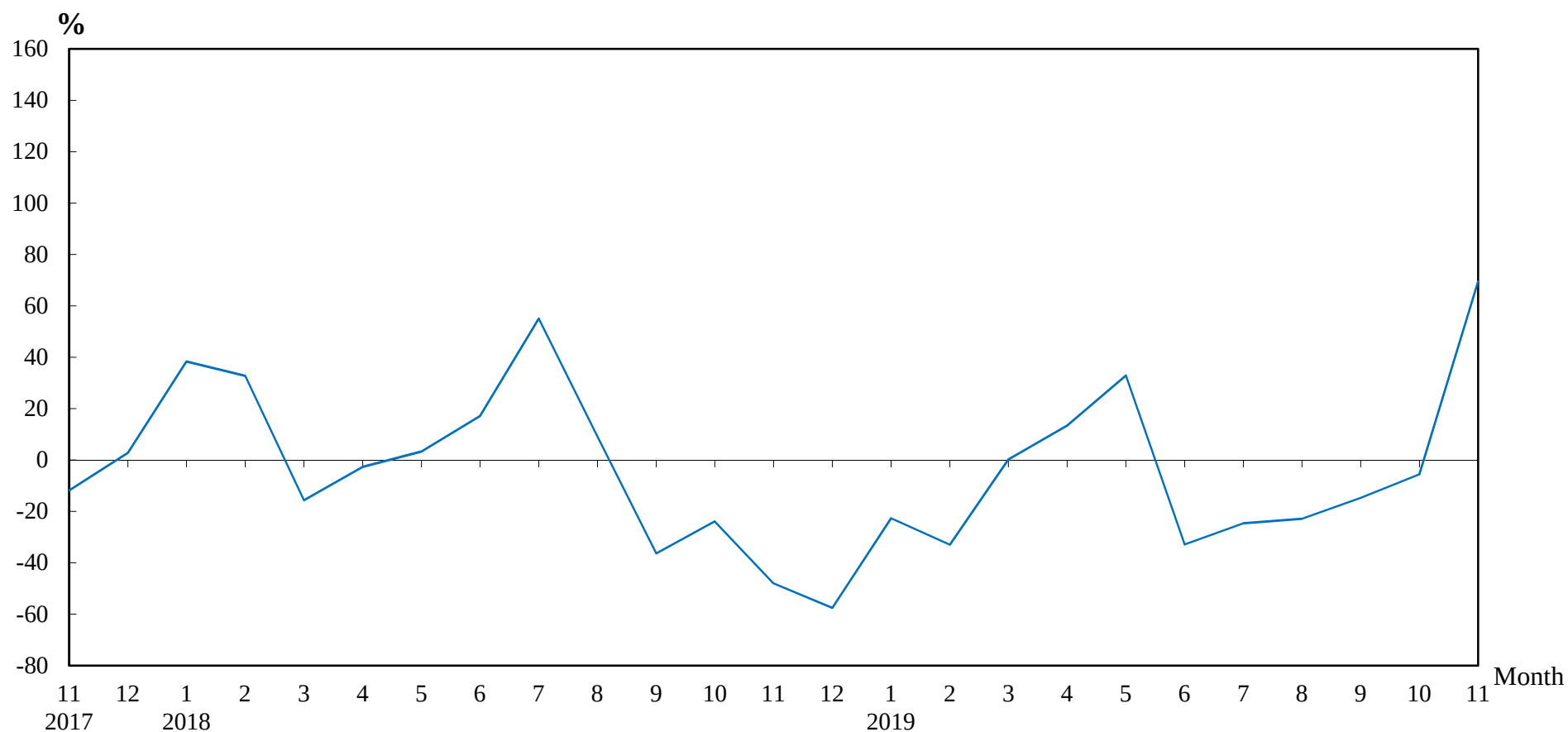
