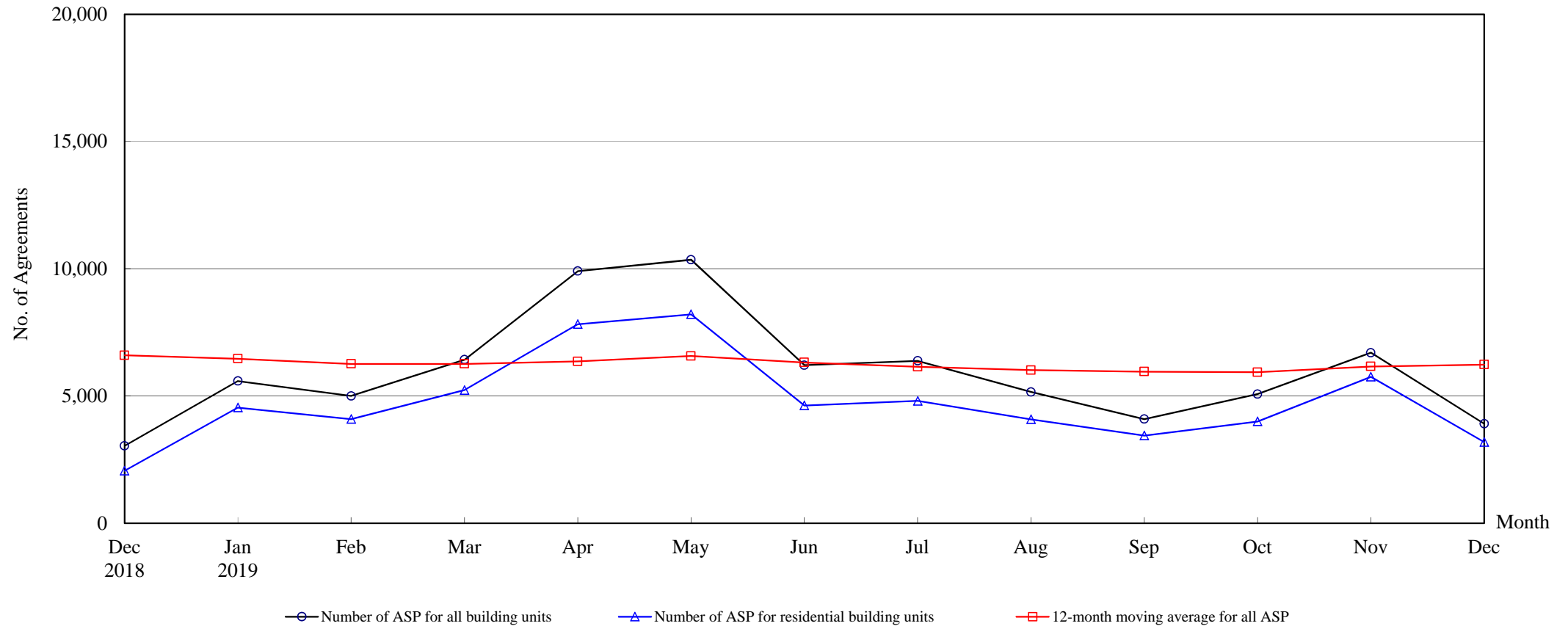

**Chart showing the number of Sale and Purchase Agreements of building units from December 2018 to December 2019**



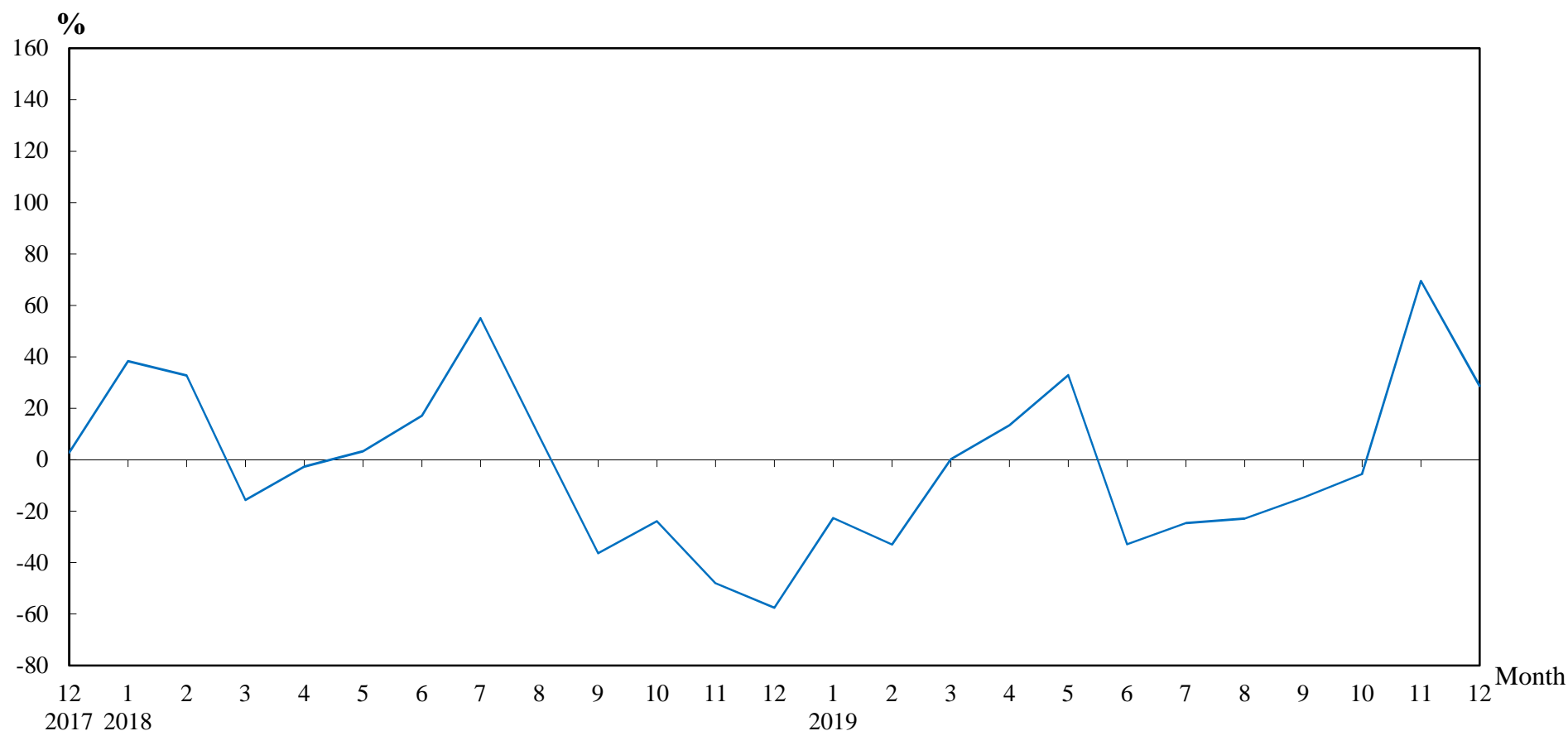
