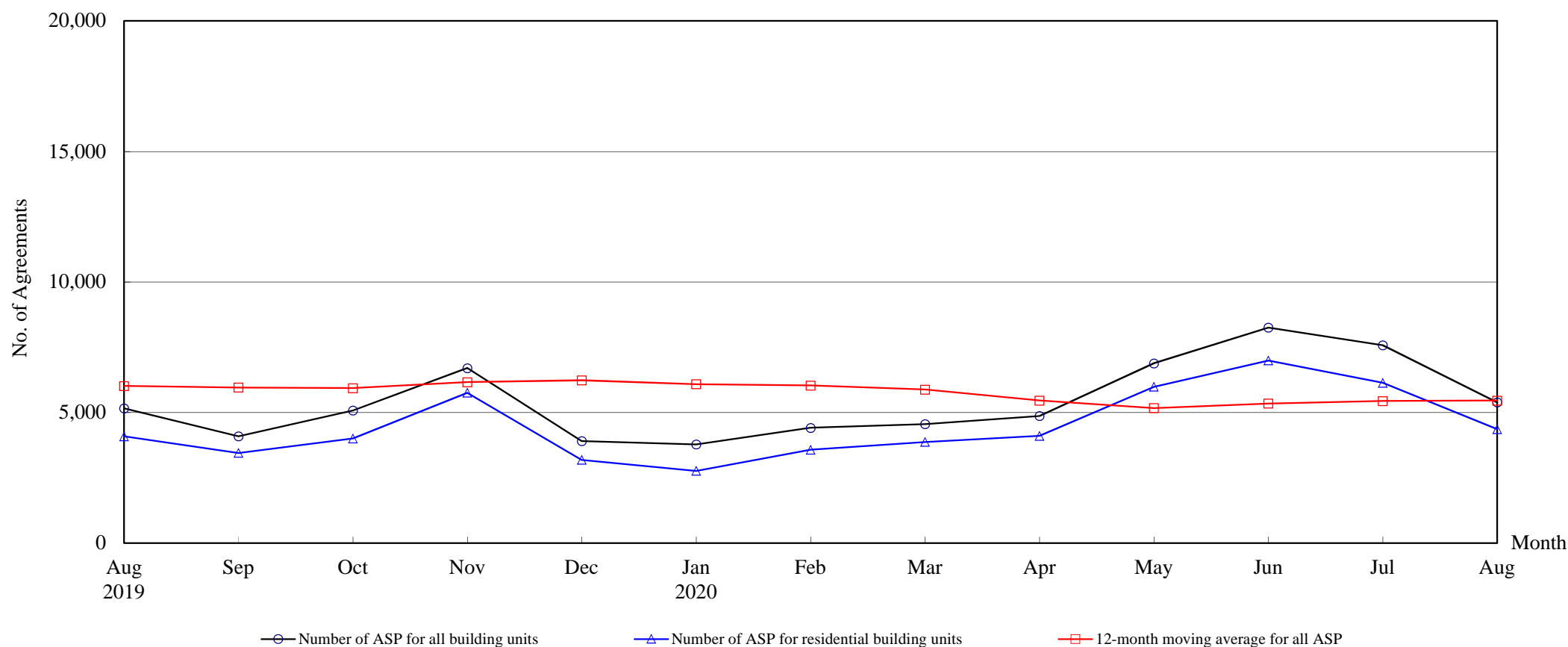

building units from August 2019 to August 2020



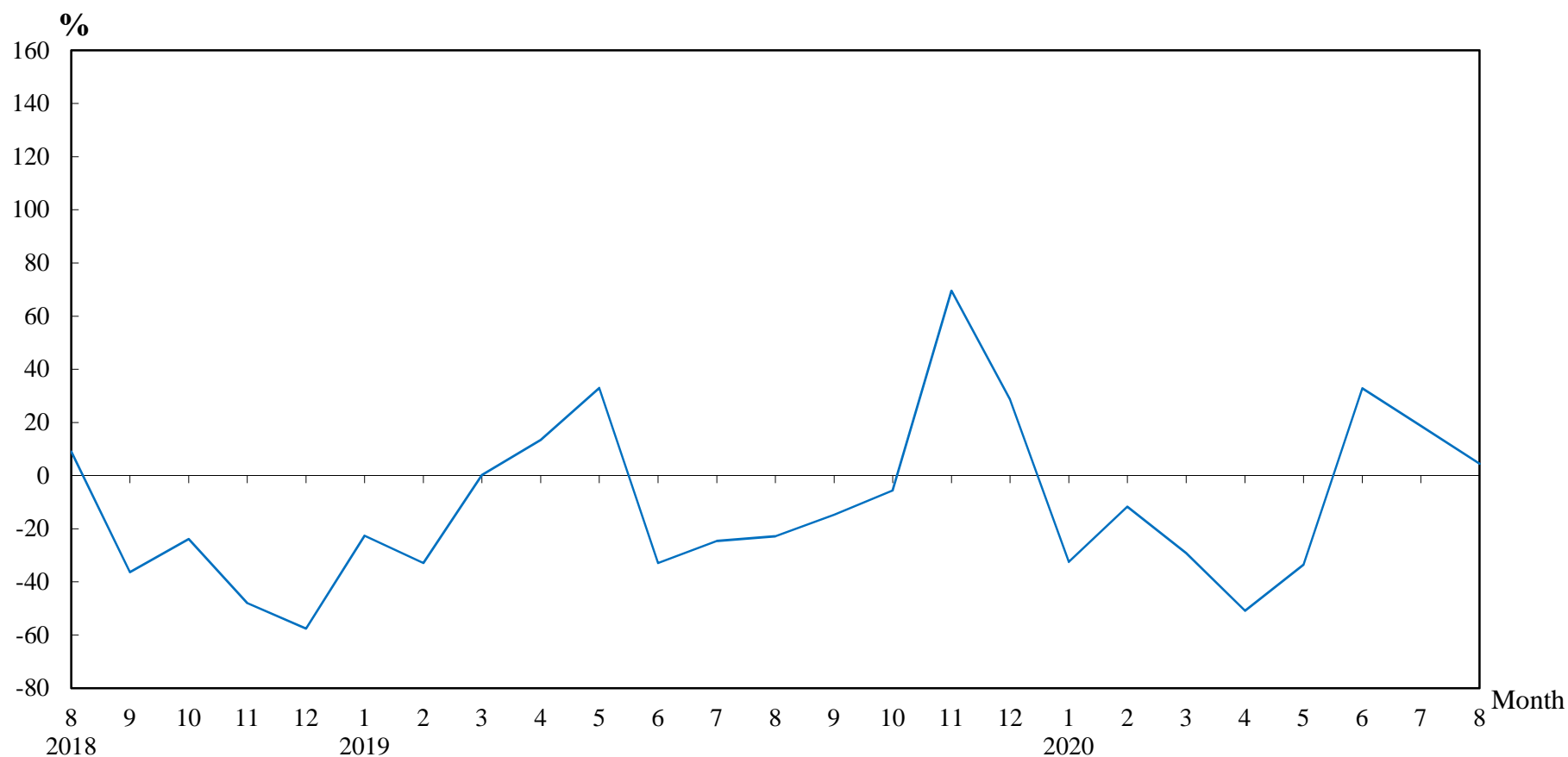
