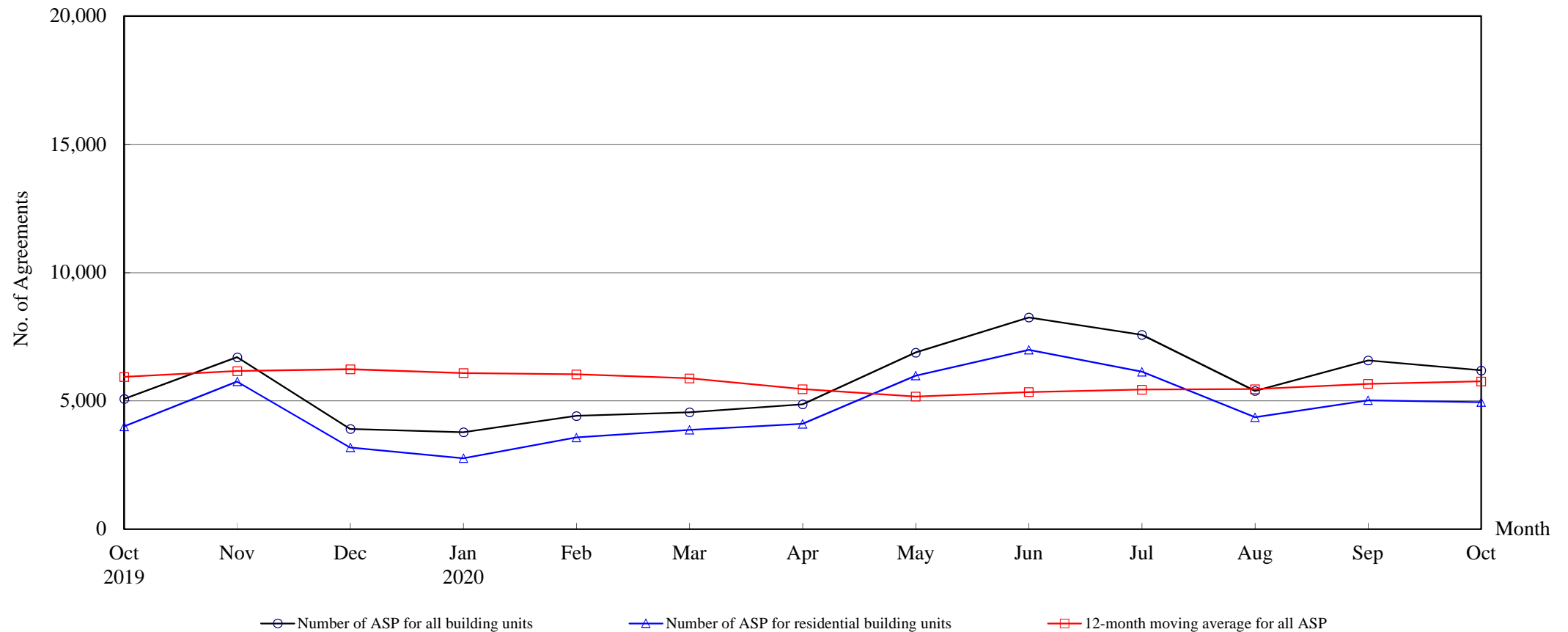

**building units from October 2019 to October 2020**



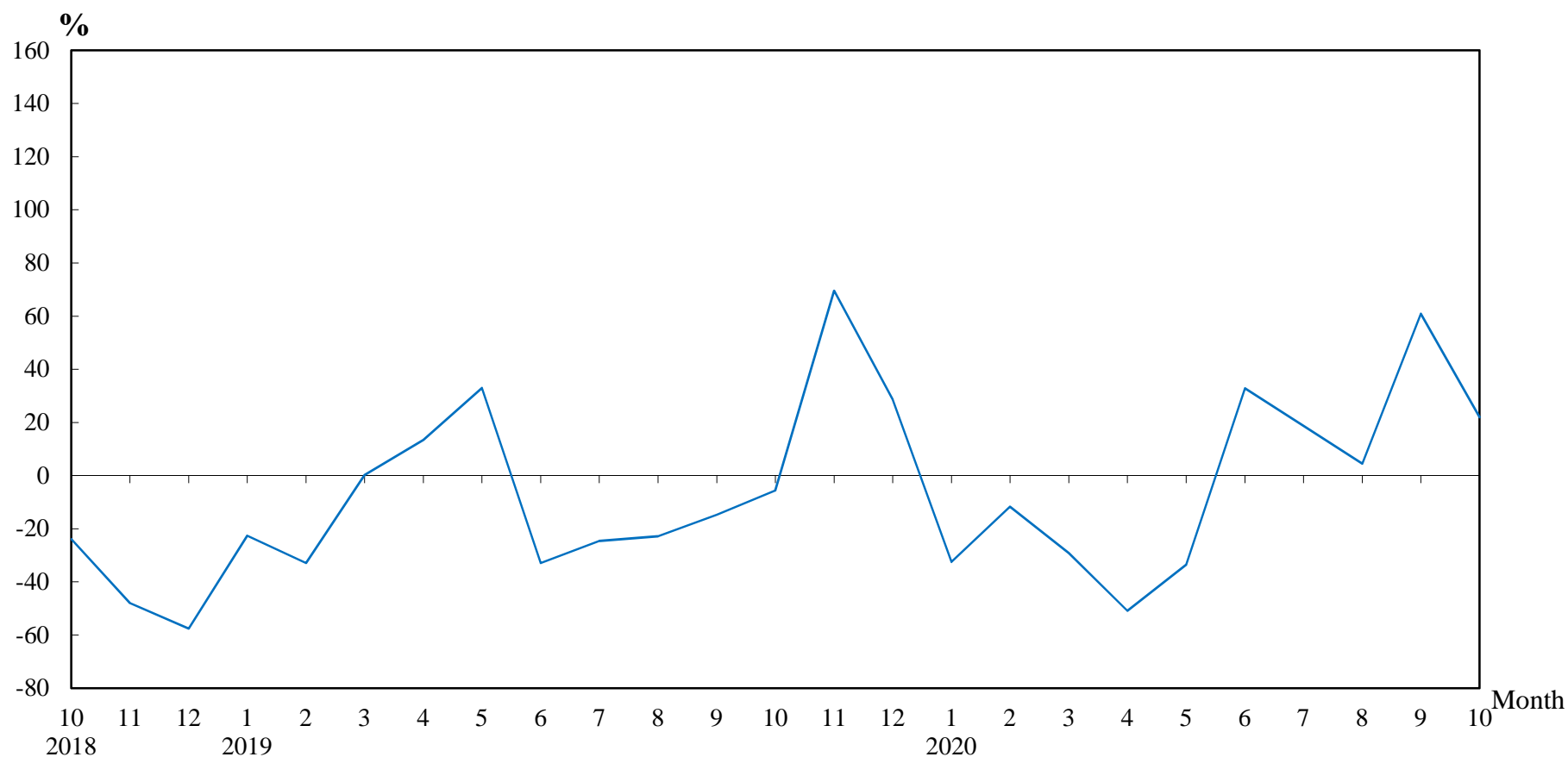
