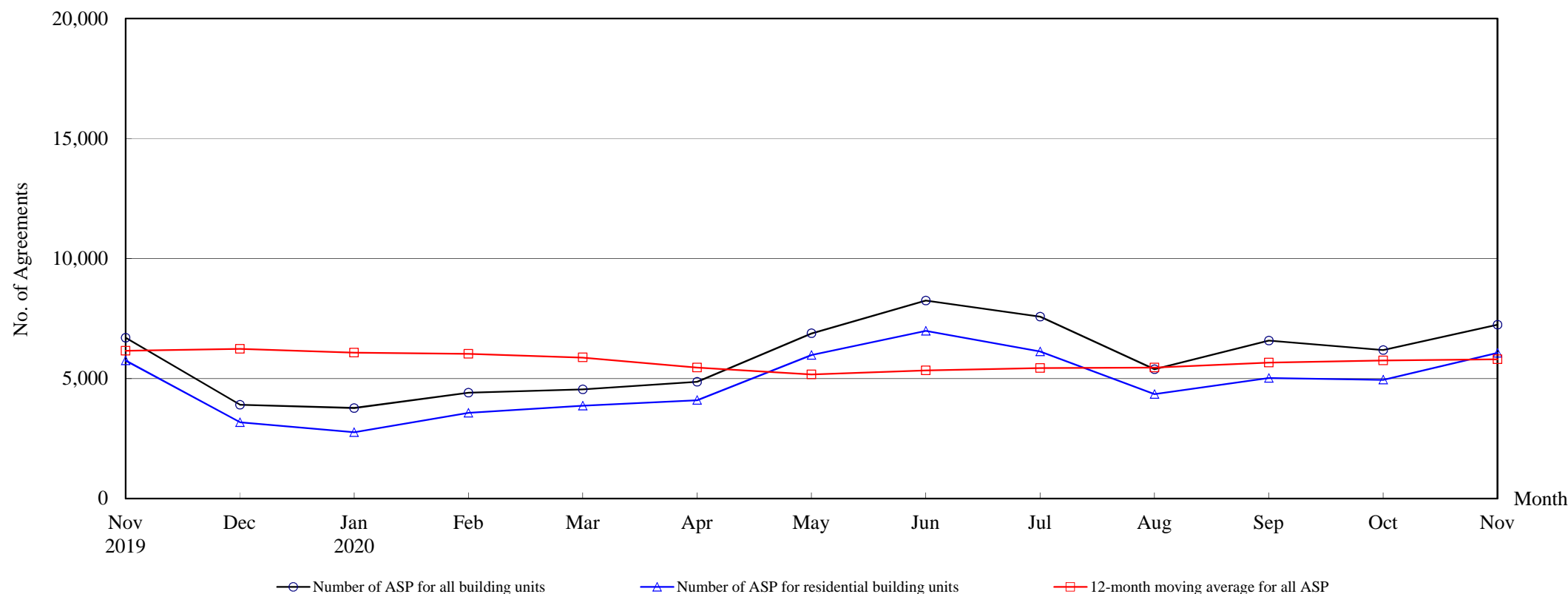

**building units from November 2019 to November 2020**



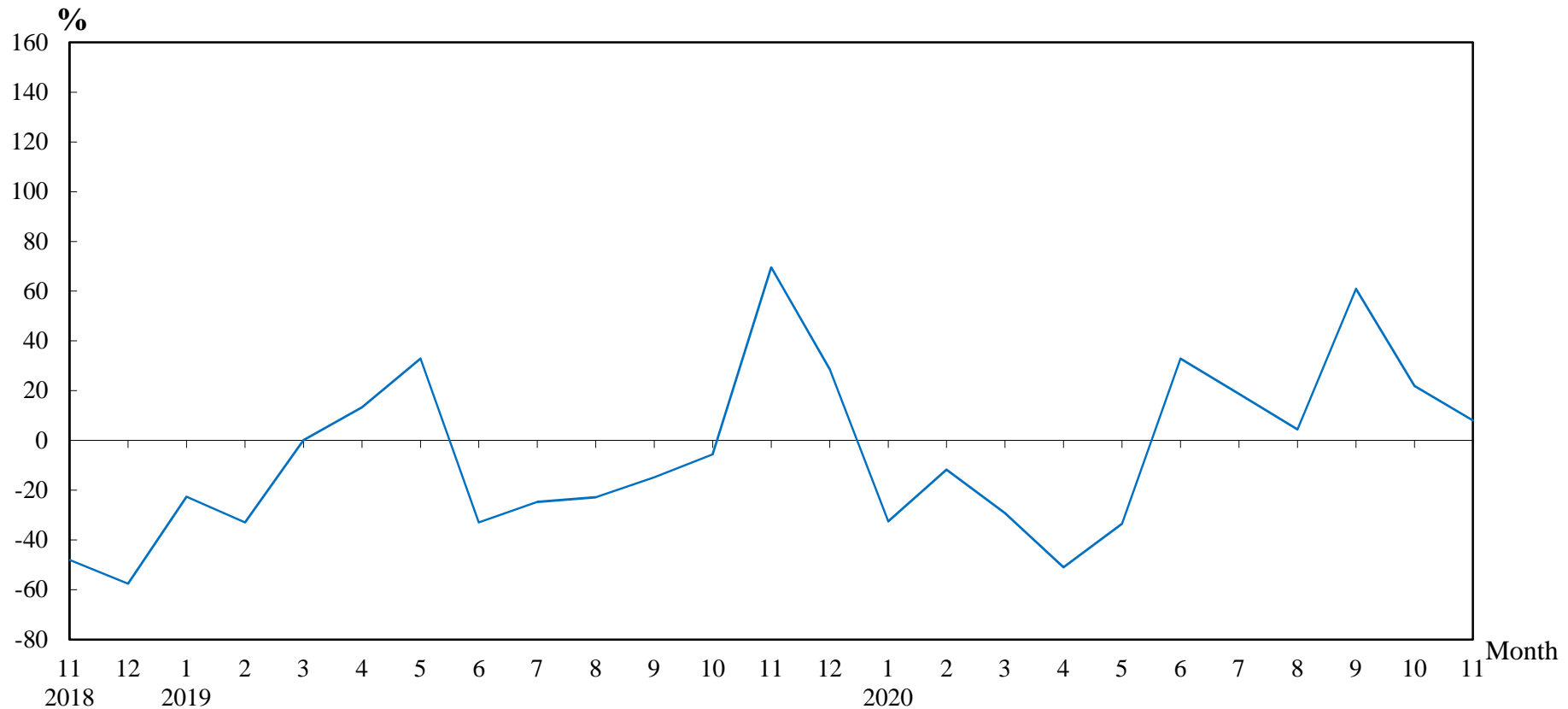
