## The following category of persons are required to receive COVID-19 nucleic acid test according to the compulsory testing notice

- (1) Any person who had been present at Lung San House, Lung Poon Court, Diamond Hill in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 23, 2020 to December 16, 2020
- (2) Any person who had been present at Ming Yan Lau, Jat Min Chuen, Sha Tin in any capacity (including but not limited to residents, visitors and workers) for

more than 2 hours at any time during the period from December 1 to 16, 2020

- (3) Any person who had been present at Glow Salon and Spa at 8/F, Silver Fortune Plaza, 1 Wellington Street, Central in any capacity (including but not limited to visitors and workers) at any time during the period from December 8 to 17, 2020
- (4) Any person who had been present at Block 8 of Kwai Shing West Estate, Kwai Chung in any capacity (including but not limited to residents, visitors and workers) for more than two hours at any time during the period from November 17 to December 9, 2020
- (5) Any person who had been present at Block 6 of Richland Gardens, Kowloon Bay in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 17 to December 9, 2020
- (6) Any person who had been present at King Tsui Court, Chai Wan in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 30 to December 19, 2020
- (7) Any person who had been present on any of the following premises in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 25, 2020 to December 21, 2020:
  - Yat Lai House of Yau Lai Estate, 9 Yau Tong Road, Kwun Tong
  - Shek Wing House of Shek Lei (II) Estate, 11 Shek Li Street, Kwai Tsing
  - Block A of Ming Wah Dai Ha, 25 A Kung Ngam Road, Eastern District
