Notes:

- (1) Salary indices reflect changes in basic wage, and other regular and guaranteed allowances and bonuses.
- (2) Real salary indices are obtained by deflating nominal salary indices by the Consumer Price Index (C).
- (3) Figures refer to the number of employed persons engaged in occupations of managers, administrators and professionals in the second quarter of the respective years. The number of employed persons includes persons aged 15 and over who have been at work for pay or profit during the 7 days before enumeration or who have had formal job attachment. Apart from employees, employers, self-employed persons, unpaid family workers and persons who were on leave/holiday during the 7 days before enumeration are also included. Government employees are, however, excluded.
- (4) As the reference periods of the salary indices are June of the respective years, June 2004 is adopted as the base period for the salary indices shown in the table.
- (5) Figures refer to the number of employed persons in the manufacturing industry.
- (6) Figures refer to the number of employed persons in the construction industry.
- (7) Figures refer to the number of employed persons in the transportation, storage, postal and courier services, and information and communications industry.
- (8) Number of employed persons in individual selected industry sections may not add up to the total due to rounding.
