23 April 2021 Details of Compulsory Testing Notices

A. Residential Building (including building for both commercial and residential uses) with one or more new preliminary positive cases

1. Any person who had been present at Hin Ming Court, 6 Chiu Shun Road, Tseung Kwan O for more than two hours at any time during the period from April 10 to April 23, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by April 26, 2021. If persons subject to compulsory testing have previously undergone testing between April 21 and April 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Workplace with one or more new confirmed cases

1. Any person who had been present at YesStyle.com Limited, 5/F, KC 100, 100 Kwai Cheong Road, Kwai Chung for more than two hours at any time during the period from April 10 to April 23, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by April 26, 2021. If persons subject to compulsory testing have previously undergone testing between April 21 and April 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

C. Places patronised by the confirmed case or the preliminary positive case

Related to a local preliminary positive case with unknown sources of infection involving N501Y mutation strain

1. Any person who had been present at Ramada Hong Kong Harbour View, 239 Queen's Road West, Sai Ying Pun, at any time during the period from March 27 to April 23, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by April 26, 2021.

- 2. Any person who had been present at any of the below specified premises at any time on April 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by April 26, 2021.
 - (a) Melbourne Plaza, 33-33A Queen's Road Central & 6-16 Chiu Lung Street, Central
 - (b) Immigration Tower, 7 Gloucester Road, Wan Chai
 - (c) Kam On Building, 176A-176F Queen's Road Central & 129-133 Wellington Street, Central

Others

3. Any person who had been present at Physical, Shop W201-W202, 2/F, West Wing, TKO Gateway, 2 Sheung Ning Road, Tseung Kwan O at any time during the period from April 10 to April 23, 2021, has to undergo testing by April 26, 2021. If persons subject to compulsory testing have previously undergone testing between April 21 and April 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

D. Specified premises under second testing

- 1. Any person who had been present at HSBC, Basement, G/F, 1/F, 2/F & 4/F, HSBC Building Tsim Sha Tsui, 82-84 Nathan Road or Standard Chartered Bank, Basement, Shop B1 on G/F & M/F, Golden Crown Court, 66-70 Nathan Road, Yau Tsim Mong at any time on April 9, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by April 26, 2021.
- 2. Any person who had been present at Wellcome, Basement, 45-53 Austin Road or Harbour City (only the shopping mall is included), 3-27 Canton Road, Yau Tsim Mong at any time on April 11, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by April 26, 2021.
- 3. Any person who had been present at Hung Lok Seafood Restaurant, G/F, 13B Pak She Praya Road, Cheung Chau at any time on April 14, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to

undergo testing by April 26, 2021.

- 4. Any person who had been present at Central Pier No. 5 or Cheung Chau Ferry Pier at any time on April 14, 2021 (including but not limited to full-time, part-time and relief staff, passengers and visitors), has to undergo testing by April 26, 2021.
- 5. Any person who had taken any of the ferries running on the route between Central and Cheung Chau operated by Sun Ferry Services Company Limited on April 14, 2021 (including but not limited to full-time, part-time and relief staff, passengers and visitors), has to undergo testing by April 26, 2021.
- 6. Any lodger who had checked out from Ramada Hong Kong Grand, 23 Austin Avenue, Yau Tsim Mong at any time during the period from April 9 to April 17, 2021, has to undergo testing by April 26, 2021.
- 7. Any person who had been present at The Centrium, 60 Wyndham Street, Central, at any time during the period from March 29 to April 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by April 26, 2021.

E. Others

- 1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from April 10 to April 23, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by April 26, 2021. If persons subject to compulsory testing who had been present at the specified premises (d) to (h) choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection (CHP), they have to return the specimen bottle with the sample by April 28, 2021. If persons subject to compulsory testing have previously undergone testing between April 21 and April 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
