The value of domestic exports classified to the food products industry in 2009 was HK\$1646.3 million.  
The value of domestic exports classified to the food products industry in 2008 was HK\$1627.2 million.  
Value change of domestic exports classified to the food products industry was HK\$+19.1 million.  
Percentage change of domestic exports classified to the food products industry was +1.2%.

The value of domestic exports classified to the beverages industry in 2009 was HK\$357.9 million.  
The value of domestic exports classified to the beverages industry in 2008 was HK\$360.0 million.  
Value change of domestic exports classified to the beverages industry was HK\$-2.2 million.  
Percentage change of domestic exports classified to the beverages industry was -0.6%.

The value of domestic exports classified to the tobacco products industry in 2009 was HK\$1986.2 million.

The value of domestic exports classified to the computer, electronic and optical products industry in 2009 was HK\$13712.0 million.

The value of domestic exports classified to the computer, electronic and optical products industry in 2008 was HK\$16570.9 million.

Value change of domestic exports classified to the computer, electronic and optical products industry was HK\$-2858.9 million.

Percentage change of domestic exports classified to the computer, electronic and optical products industry was -17.3%.

The value of domestic exports classified to the electrical equipment industry in 2009 was HK\$1840.9 million.

The value of domestic exports classified to the electrical equipment industry in 2008 was HK\$2465.0 million.

Value change of domestic exports classified to the electrical equipment industry was HK\$-624.1 million.

Percentage change of domestic exports classified to the electrical equipment industry was -25.3%.

The value of domestic exports classified to the machinery and equipment n.e.c. industry in 2009 was HK\$2394.3 million.

The value of domestic exports classified to the machinery and equipment n.e.c. industry in 2008 was HK\$3516.2 million.

Value change of domestic exports classified to the machinery and equipment n.e.c. industry was HK\$-1121.9 million.

Percentage change of domestic exports classified to the machinery and equipment n.e.c. industry was -31.9%.

The value of domestic exports classified to other manufacturing industries in 2009 was HK\$7811.9 million.  
The value of domestic exports classified to other manufacturing industries in 2008 was HK\$11109.5 million.  
Value change of domestic exports classified to other manufacturing industries was HK\$-3297.6 million.  
Percentage change of domestic exports classified to other manufacturing industries was -29.7%.

Total value of domestic exports in 2009 was HK\$ 55824.1 million.  
Total value of domestic exports in 2008 was HK\$ 88901.5 million.  
Value change of total domestic exports was HK\$ -33077.4 million.  
Percentage change of total domestic exports was -37.2%.

Note 1 : The statistics in the above table are derived by re-grouping the merchandise domestic export items (except gold and specie) under the Standard International Trade Classification, Revision 3 according to the industries in which these items are normally produced. Owing to the change in trade classification, the above statistics may not be strictly comparable with those published for earlier years.

Note 2 : The above statistics are compiled based on the Hong Kong Standard Industrial Classification Version 2.0.

Note 3 : There may be a slight discrepancy between the sum of individual items and the total as shown in the table owing to rounding. The percentage changes are calculated from unrounded figures.
