- (3) 任何人士不論以何種身分(包括但不限於住客、訪客及工作人員)，在 2020 年 11 月 20 日至 12 月 15 日期間曾身處任何下列地方超過兩小時：

  - 黃大仙清水灣道 55 號彩雲(二)邨明麗樓；

- (1) Any person who had been present at Kwai Tung House of Tung Tau (II) Estate, Wong Tai Sin in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 22 to December 14, 2020
- (2) Any person who had been present at Unit 1C, Fung Nin Building, 28-32 Tai Wing Lane, Tai Po in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 15, 2020 to December 15, 2020
- (3) Any person who had been present on any of the following premises in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 20, 2020 to December 15, 2020:
  - Tat Yi House, Po Tat Estate, 2 Po Lam Road, Kwun Tong
  - Ming Lai House, Choi Wan (II) Estate, 55 Clear Water Bay Road, Wong Tai Sin
- (4) Any person who had been present at Lung San House, Lung Poon Court, Diamond Hill in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 23, 2020 to December 16, 2020
- (5) Any person who had been present at Ming Yan Lau, Jat Min Chuen, Sha Tin in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from December 1 to 16, 2020
- (6) Any person who had been present at Glow Salon and Spa at 8/F, Silver Fortune Plaza, 1 Wellington Street, Central in any capacity (including but not limited to visitors and workers) at any time during the period from December 8 to 17, 2020
- (7) Any person who had been present at Block 8 of Kwai Shing West Estate, Kwai Chung in any capacity (including but not limited to residents, visitors and workers) for more than two hours at any time during the period from November 17 to December 9, 2020

- (8) Any person who had been present at Block 6 of Richland Gardens, Kowloon Bay in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 17 to December 9, 2020
