- (1) 任何人士不論以何種身分（包括但不限於住客、訪客及工作人員），在 2020 年 11 月 25 日至 12 月 21 日期間曾身處任何下列地方超過兩小時：
  - 觀塘油塘道 9 號油麗邨逸麗樓
  - 葵青石梨街 11 號石籬（二）邨石榮樓
  - 東區阿公岩道 25 號明華大廈 A 座
- (2) 任何人士不論以何種身分（包括但不限於住客、訪客及工作人員），在 2020 年 12 月 1 日至 23 日期間曾身處藍田平田邨平誠樓超過兩小時
- (3) 任何人士不論以何種身分（包括但不限於住客、訪客及工作人員），在 2020 年 11 月 22 日至 12 月 14 日期間曾身處黃大仙東頭（二）邨貴東樓超過兩小時
- (4) 任何人士不論以何種身分（包括但不限於住客、訪客及工作人員），在 2020 年 11 月 13 日至 12 月 24 日期間曾身處鑽石山富山邨富仁樓超過兩小時
- (5) 任何人士不論以何種身分（包括但不限於住客、訪客及工作人員），在 2020 年 12 月 5 日至 12 月 25 日期間曾身處觀塘牛頭角道觀塘花園大廈玉蓮臺 2 座超過兩小時

### **The following category of persons are required to receive COVID-19 nucleic acid test according to the compulsory testing notice**

- (1) Any person who had been present on any of the following premises in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 25 to December 21, 2020:
  - Yat Lai House of Yau Lai Estate, 9 Yau Tong Road, Kwun Tong
  - Shek Wing House of Shek Lei (II) Estate, 11 Shek Li Street, Kwai Tsing
  - Block A of Ming Wah Dai Ha, 25 A Kung Ngam Road, Eastern District
- (2) Any person who had been present at Ping Shing House of Ping Tin Estate, Lam

Tin in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from December 1 to 23, 2020

- (3) Any person who had been present at Kwai Tung House of Tung Tau (II) Estate, Wong Tai Sin in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 22 to December 14, 2020
- (4) Any person who had been present at Fu Yan House of Fu Shan Estate, Diamond Hill in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from November 13 to December 24, 2020
- (5) Any person who had been present at Lotus Tower Block 2, Kwun Tong Garden Estate, Ngau Tau Kok Road, Kwun Tong in any capacity (including but not limited to residents, visitors and workers) for more than 2 hours at any time during the period from December 5 to December 25, 2020
