

## **COVID-19 Vaccination Programme**

### **Cases Involving Persons Sent to Hospital**

For the past 24 hours ended at 0000 hours on March 8, there were eight cases involving medical treatment at hospital from community vaccination centres.

#### **Community Vaccination Centre at Yuen Wo Road Sports Centre**

A female aged 61 went to Yuen Wo Road Sports Centre for vaccination on March 7. After receiving the vaccine, she felt dizzy and was sent to Prince of Wales Hospital at 1215 hours in a stable condition. After treatment, she was discharged.

#### **Community Vaccination Centre at Yuen Wo Road Sports Centre**

A female aged 57 went to Yuen Wo Road Sports Centre for vaccination on March 7. After receiving the vaccine, she suffered from headache and palpitation. She was sent to Prince of Wales Hospital at 1215 hours in a stable condition. After treatment, she was discharged.

#### **Community Vaccination Centre at Hiu Kwong Street Sports Centre**

A female aged 49 went to Hiu Kwong Street Sports Centre for vaccination on March 7. After receiving the vaccine, she felt chest discomfort with burning sensation. She was sent to United Christian Hospital at 1245 hours in a stable condition. After treatment, she was discharged.

#### **Community Vaccination Centre at Tseung Kwan O Sports Centre**

A male aged 76 went to Tseung Kwan O Sports Centre for vaccination on March 7. After receiving the vaccine, he suffered from dizziness and left side body numbness. He was sent to Tseung Kwan O Hospital at 1257 hours in a stable condition. After treatment, he was admitted for observation and was later discharged.

A female aged 45 went to Kwun Chung Sports Centre for vaccination on March 7. After receiving the vaccine, she suffered from headache, rash and itchiness on neck. She was sent to Queen Elizabeth Hospital at 1321 hours in a stable condition. After treatment, she was discharged.

A female aged 66 went to Kwun Chung Sports Centre for vaccination on March 7. After receiving the vaccine, she suffered from chest pain and palpitation. She was sent to Queen Elizabeth Hospital at 1356 hours in a stable condition. After treatment, she was admitted for observation.

### **Community Vaccination Centre at Yau Oi Sports Centre**

A male aged 70 went to Yau Oi Sports Centre for vaccination on March 7. After receiving the vaccine, he felt chest discomfort. He was sent to Tuen Mun Hospital at 1559 hours in a stable condition. After treatment, he was admitted for observation and was later discharged.

### **Community Vaccination Centre at Lung Sum Avenue Sports Centre**

A female aged 60 went to Lung Sum Avenue Sports Centre for vaccination on March 7. After receiving the vaccine, she suffered from rash over hands and arms. She was sent to North District Hospital at 1735 hours in a stable condition. After treatment, she was discharged.
