

COVID-19 Vaccination Programme Cases Involving Persons Sent to Hospital

In the past 24 hours ending at 0000 hours on March 18, there were 12 cases involving medical treatment at hospital.

Community Vaccination Centre at Yuen Long Sports Centre

A male aged 35 suffered from convulsion after vaccination with the BioNTech vaccine on March 17. He was sent to Pok Oi Hospital at 0954 hours in stable condition. He was discharged against medical advice after treatment.

A female aged 64 suffered from dizziness, hypertension and weakness of left upper arm after vaccination with the BioNTech vaccine on March 17. She was sent to Pok Oi Hospital at 1213 hours in stable condition. She was discharged after treatment.

A female aged 60 suffered from left upper limb numbness after vaccination with the BioNTech vaccine on March 17. She was sent to Pok Oi Hospital at 1948 hours in stable condition. She was discharged after treatment.
