

COVID-19 Vaccination Programme Cases Involving Persons Sent to Hospital

In the past 24 hours ending at 0000 hours on March 19, there were 12 cases involving medical treatment at hospital.

Community Vaccination Centre at Lung Sum Avenue Sports Centre

A male aged 47 suffered from suspected vasovagal attack after vaccination with the BioNTech vaccine on March 18. He was sent to North District Hospital at 1110 hours in stable condition. He was admitted for observation after treatment.

A female aged 26 suffered from vaccine allergy after vaccination with the BioNTech vaccine on March 18. She was sent to North District Hospital at 2018 hours in stable condition. She was discharged after treatment.

Community Vaccination Centre at Tsuen King Circuit Sports Centre

A male aged 17 suffered from abdominal pain and loss of consciousness after vaccination with the BioNTech vaccine on March 18. He was sent to Yan Chai Hospital at 1115 hours in stable condition. He was discharged after treatment.
