Details of Compulsory Testing Notices

(Persons who have completed a COVID-19 vaccination course¹ would be taken to have complied with the requirements set out in the compulsory testing notices)

A. Specified premises under second testing

1. Any person who had been present at Ramada Hong Kong Harbour View, 239 Queen's Road West, Sai Ying Pun, Hong Kong at any time during the period from March 27 to April 23, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 3, 2021.
2. Any person who had been present at any of the below specified premises at any time on April 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 3, 2021.
 - a. Melbourne Plaza, 33-33A Queen's Road Central & 6-16 Chiu Lung Street, Central, Hong Kong
 - b. Immigration Tower, 7 Gloucester Road, Wan Chai, Hong Kong
 - c. Kam On Building, 176A-176F Queen's Road Central & 129-133 Wellington Street, Central, Hong Kong
3. Any person who had been present at Kennedy Terrace, 8 Kennedy Road, Mid-levels, Hong Kong at any time during the period from April 17 to April 24, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by May 3, 2021.

¹ If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice regardless of whether or not the test was conducted for complying with this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before April 19, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before April 19, 2021.

B. Specified premises under third testing

1. Any person who had been present at HSBC, Basement, G/F, 1/F, 2/F & 4/F, HSBC Building Tsim Sha Tsui, 82-84 Nathan Road or Standard Chartered Bank, Basement, Shop B1 on G/F & M/F, Golden Crown Court, 66-70 Nathan Road, Yau Tsim Mong, Kowloon, Hong Kong at any time on April 9, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 3, 2021.
2. Any person who had been present at Wellcome, Basement, 45-53 Austin Road or Harbour City (only the shopping mall is included), 3-27 Canton Road, Yau Tsim Mong, Kowloon, Hong Kong at any time on April 11, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 3, 2021.
3. Any person who had been present at Hung Lok Seafood Restaurant, G/F, 13B Pak She Praya Road, Cheung Chau, New Territories, Hong Kong at any time on April 14, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 3, 2021.
4. Any person who had been present at Central Pier No. 5, Central or Cheung Chau Ferry Pier, New Territories, Hong Kong at any time on April 14, 2021 (including but not limited to full-time, part-time and relief staff, passengers and visitors), has to undergo testing by May 3, 2021.
5. Any person who had taken any of the ferries running on the route between Central and Cheung Chau operated by Sun Ferry Services Company Limited on April 14, 2021 (including but not limited to full-time, part-time and relief staff, passengers and visitors), has to undergo testing by May 3, 2021.
6. Any lodger who had checked out from Ramada Hong Kong Grand, 23 Austin Avenue, Yau Tsim Mong, Kowloon, Hong Kong at any time during the period from April 9 to April 17 2021, has to undergo testing by May 3, 2021.
7. Any person who had been present at The Centrium, 60 Wyndham Street, Central, Hong Kong at any time during the period from March 29 to April 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 3, 2021.

C. Others

1. Any foreign domestic helper who had not completed a COVID-19 vaccination² has to undergo testing by May 9, 2021. If persons subject to compulsory testing have previously undergone testing on April 30, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

2. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from April 17 to April 30, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by May 3, 2021. If persons subject to compulsory testing who had been present at the specified premises (f) to (k) choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection (CHP), they have to return the specimen bottle with the sample by May 5, 2021. If persons subject to compulsory testing have previously undergone testing between April 28 and April 30, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
