**Details of Compulsory Testing Notices**

*(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)*

**A. Workplace with a new preliminary positive case**

1. Any person who had been present at BGI Health (HK) Company Limited, 16 Dai Fu Street, Tai Po Industrial Estate, Tai Po, New Territories, Hong Kong for more than two hours at any time during the period from April 23 to May 6, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 9, 2021. If persons subject to compulsory testing have previously undergone testing between May 4 and May 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

**B. Places patronised by the close contacts of the previous local confirmed case involving N501Y mutant strain**

1. Any person who had been present at Deep Water Bay Beach, Hong Kong at any time on April 25 or May 1, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 9, 2021.

**C. Specified premises under second testing**

1. Any person who had been present at Fu Tung Plaza (Fu Tung Market is included), 6 Fu Tung Street, Tung Chung, Lantau Island, New Territories, Hong Kong at any time during the period from April 9 to April 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors),

<sup>1</sup> If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice regardless of whether or not the test was conducted for complying with this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before April 25, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before April 25, 2021.

has to undergo testing by May 9, 2021. If persons subject to compulsory testing have previously undergone testing between May 4 and May 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

2. Any person who had been present at St. Thomas the Apostle Church, 5 Tsing Luk Street, Tsing Yi, New Territories, Hong Kong at any time on April 11 or April 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 9, 2021.
3. Any person who had been present at Man Tung Road Park, 55 Man Tung Road, Tung Chung, Lantau Island, New Territories, Hong Kong at any time on April 11, April 18 or April 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 9, 2021. If persons subject to compulsory testing have previously undergone testing between May 4 and May 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Fusion, Shop 22-23, 1/F, Caribbean Bazaar, 1 Kin Tung Road, Tung Chung, Lantau Island, New Territories, Hong Kong at any time on April 12 or April 16, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 9, 2021. If persons subject to compulsory testing have previously undergone testing between May 4 and May 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Tower 11, Carmel Cove, Caribbean Coast, 1 Kin Tung Road, Tung Chung, Lantau Island, New Territories, Hong Kong at any time during the period from April 16 to April 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 9, 2021. If persons subject to compulsory testing have previously undergone testing between May 4 and May 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

## **D. Others**

1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from April 23 to May 6, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by May 9, 2021. If persons subject to compulsory testing who had been present at the specified premises (1) to (9) choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottle with the sample by May 11, 2021. If persons subject to compulsory testing have previously undergone testing between May 4 and May 6, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
