**Details of Compulsory Testing Notice**

*(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)*

**A. Residential Building (including building for both commercial and residential uses) with one or more new cases**

1. Any person who had been present at No. 29 Staunton Street, Central, Hong Kong for more than two hours at any time during the period from April 23 to May 13, 2021 (including but not limited to residents, visitors and workers), has to undergo testing by May 16, 2021. If persons subject to compulsory testing have previously undergone testing between May 11 and May 13, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

**B. Specified premises under additional testing**

1. Any person who had been present at Fu Tung Plaza (Fu Tung Market is included), 6 Fu Tung Street, Tung Chung, Lantau Island, New Territories, Hong Kong for more than one hour at any time during the period from April 9 to April 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 16, 2021. If persons subject to compulsory testing have previously undergone testing between May 11 and May 13, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Citygate (only the shopping mall is included), 18-20 Tat Tung Road & 41 Man Tung Road, Tung Chung, Lantau Island, New Territories, Hong Kong for more than one hour at any time during the period from April 10 to April 26, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 16, 2021. If persons subject to compulsory testing have previously undergone testing between May 11 and May 13, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

<sup>1</sup> If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before May 2, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before May 2, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before May 2, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website ([www.coronavirus.gov.hk/pdf/list\\_of\\_recognised\\_covid19\\_vaccines.pdf](http://www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf)).

3. Any person who had been present at Man Tung Road Park, 55 Man Tung Road, Tung Chung, Lantau Island, New Territories, Hong Kong for more than one hour at any time on April 11, April 18 or April 25, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 16, 2021. If persons subject to compulsory testing have previously undergone testing between May 11 and May 13, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at Annunciation Catholic Kindergarten, 11 On Yin Street, Tsuen Wan, New Territories, Hong Kong for more than one hour at any time during the period from April 22 to May 3, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by May 16, 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottle with the sample by May 18, 2021. If persons subject to compulsory testing have previously undergone testing between May 11 and May 13, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Yip's Children's Choral & Performing Arts Centre, Unit 2302-2303, 23/F, Tower 2, Metroplaza, Kwai Fong, New Territories, Hong Kong for more than one hour at any time on April 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 16, 2021. If persons subject to compulsory testing have previously undergone testing between May 11 and May 13, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
6. Any person who had been present at Deep Water Bay Beach, Hong Kong for more than one hour at any time on April 25, April 30, May 1 or May 2, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by May 16, 2021. If persons subject to compulsory testing have previously undergone testing between May 11 and May 13, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

#### C. Others

1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from April 30 to May 13, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by May 16, 2021. If persons subject to compulsory testing who had been present at the specified premises (1) to (12) choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottle with the sample by May 18, 2021. If persons subject to compulsory testing have previously undergone testing between May 11 and May 13, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
