## **Details of Compulsory Testing Notice**

(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)

- 1. Any person who had been present at St. Raphael's Catholic Cemetery, Cheung Sha Wan, Kowloon, Hong Kong for more than one hour at any time during the period from 12:00 noon to 6:00 p.m. on June 3, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Hok Yau Club's Student Guidance Centre, No. 129, G/F, Lai Ho House, Lai Kok Estate, Cheung Sha Wan, Kowloon, Hong Kong for more than one hour at any time during the period from 12:00 noon to 6:00 p.m. on June 3, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at Tin Shing Market, G/F, Tin Shing Shopping Centre, Tin Shui Wai, New Territories, Hong Kong for more than one hour at any time during the period from 12:00 noon to 6:00 p.m. on May 28, June 1, June 2 or June 3, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 4. Any person who had been present at Tai Po (North) Social Security Field Unit,

If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before May 24, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before May 24, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before May 24, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website (www.coronavirus.gov.hk/pdf/list of recognised covid19 vaccines.pdf).

- 4/F, Tai Po Government Offices, 1 Ting Kok Road, Tai Po, New Territories, Hong Kong for more than one hour at any time during the period from 9:00 a.m. to 2:00 p.m. on May 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 5. Any person who had been present at Gyujin Shabu & Sukiyaki Restaurant (Tai Po Mega Mall), Shop 217, 2/F, Zone B, Tai Po Mega Mall, 8-10 On Pong Road, Tai Po, New Territories, Hong Kong for more than one hour at any time during the period from 12:00 noon to 6:00 p.m. on May 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 6. Any person who had been present at Shun Fuk Home for Aged, 1/F, Tai Po Commercial Centre, 152-172 Kwong Fuk Road, Tai Po, New Territories, Hong Kong for more than one hour at any time during the period from 12:00 noon to 6:00 p.m. on May 28, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 7. Any person who had been present at C.P. Lin & Co., Unit B, 19/F, United Centre, 95 Queensway, Admiralty, Hong Kong for more than one hour at any time during the period from 9:00 a.m. to 2:00 p.m. on May 26, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 8. Any person who had been present at Ping Shan Tin Shui Wai Public Library, High Block, Ping Shan Tin Shui Wai Leisure and Cultural Building, 1 Tsui Sing Road, Tin Shui Wai, New Territories, Hong Kong for more than one hour at any time during the period from 9:00 a.m. to 2:00 p.m. on June 1, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 9. Any person who had been present at Tai Po Hui Cooked Food Centre, 2/F, Tai

- Po Complex, 8 Heung Sze Wui Street, Tai Po, New Territories, Hong Kong for more than one hour at any time during the period from 9:00 a.m. to 2:00 p.m. on May 15, May 22, May 26 or June 2, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 10. Any person who had been present at Food Court, 8/F, Fortune Metropolis, 6 Metropolis Drive, Hung Hom, Kowloon, Hong Kong for more than one hour at any time during the period from 12:00 noon to 6:00 p.m. on May 26, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 11. Any person who had been present at Pok Oi Hospital The Chinese University of Hong Kong Chinese Medicine Clinic cum Training and Research Centre (Yuen Long District), 3/F, Madam Yung Fung Shee Health Centre, 26 Sai Ching Street, Yuen Long, New Territories, Hong Kong for more than one hour at any time during the period from 12:00 noon to 6:00 p.m. on May 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 12. Any person who had been present at PARKnSHOP Supermarket, Shop No. 1, G/F, Commercial Centre, Kingswood Villas Phase I, Tin Shui Wai, New Territories, Hong Kong for more than one hour at any time during the period from 9:00 a.m. to 2:00 p.m. on May 30, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 13. Any person who had been present at Ward 4AR in the Tai Po Hospital, 9 Chuen On Road, Tai Po, New Territories, Hong Kong for more than one hour at any time during the period from 9:00 a.m. to 2:00 p.m. on June 2, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 7, 2021. If persons subject to compulsory testing have previously undergone testing between June 3 and June 5, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
