**Details of Compulsory Testing Notice**

*(Persons who have completed a COVID-19 vaccination course<sup>1</sup> would be taken to have complied with the requirements set out in the compulsory testing notices)*

1. Any person who had been present at St. Matthias' Church Chiu Chun Kindergarten, G/F - 2/F, 9 Ma Miu Road, Yuen Long, New Territories, Hong Kong for more than two hours at any time during the period from June 5 to June 18, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by June 20, 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by June 22, 2021. If persons subject to compulsory testing have previously undergone testing between June 16 and June 18, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Students of the schools at the levels specified below and teachers (including but not limited to full-time, part-time and relief teachers) of the specified schools who had face-to-face lessons with such students at the specified levels during the period from June 5 to June 18, 2021 have to undergo testing by June 20, 2021. If persons subject to compulsory testing have previously undergone testing between June 16 and June 18, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
  - (1) Primary 4 of Beacon Hill School, 23 Ede Road, Kowloon Tong, Kowloon, Hong Kong
  - (2) Primary 1 of Tai Po Methodist School, 10 Tung Leung Road, Tai Po, New Territories, Hong Kong
  - (3) Primary 2 of St. Hilary's Primary School, 6 Wan Tau Street, Tai Po, New Territories, Hong Kong

<sup>1</sup> If a person subject to compulsory testing has completed a COVID-19 vaccination course, he/she would be taken to have complied with the requirements set out in this Notice. For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before June 6, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before June 6, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before June 6, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website ([www.coronavirus.gov.hk/pdf/list\\_of\\_recognised\\_covid19\\_vaccines.pdf](http://www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf)).
