23 June 2021 Details of Compulsory Testing Notice

A. Places patronised by a preliminary positive case involving L452R mutant strain

- 1. Any person who had been present at Uptown Plaza (only the shopping mall is included), 9 Nam Wan Road, Tai Po, New Territories, Hong Kong at any time on June 3, June 9, June 18, June 20 or June 22, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 25, 2021. If persons subject to compulsory testing have previously undergone testing between June 21 and June 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 2. Any person who had been present at Level 5 or 6, Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time on any day of June 4 to June 8, June 11, June 13 or June 15 to June 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 25, 2021. If persons subject to compulsory testing have previously undergone testing between June 21 and June 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 3. Any person who had been present at Level 7, Terminal 1, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time on June 5 or June 17, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 25, 2021. If persons subject to compulsory testing have previously undergone testing between June 21 and June 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 4. Any person who had been present at the Midfield Concourse, Hong Kong International Airport, 1 Cheong Tat Road, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time on June 4, June 7, June 8, June 11 or June 13, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 25, 2021. If persons subject to compulsory testing have previously undergone testing between June 21 and June 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice. The relevant requirement does not apply to persons who are undergoing quarantine during June 23 to June 25, 2021 pursuant to a quarantine order under section 3 of the Compulsory Quarantine of Certain Persons Arriving at Hong Kong Regulation (Cap. 599C) or the Compulsory Quarantine of Persons Arriving at Hong Kong from Foreign Places

- 5. Any person who had been present at Wan Tau Tong Shopping Centre, 10 Hiu Wan Road, Tai Po, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 21, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 25, 2021. If persons subject to compulsory testing have previously undergone testing between June 21 and June 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 6. Any person who had been present at Man Lee, Shop 15, G/F, Tai Po Plaza, 1 On Tai Road, Tai Po, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 19, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 25, 2021. If persons subject to compulsory testing have previously undergone testing between June 21 and June 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 7. Any person who had been present at Come Thai House Thai Food Restaurant, 1 Wong Nai Uk Village, Tung Chung, Lantau Island, New Territories, Hong Kong at any time during the period from 6:00 p.m. to 10:00 p.m. on June 18, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 25, 2021. If persons subject to compulsory testing have previously undergone testing between June 21 and June 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
- 8. Any person who had been present at Airport Staff Canteen Sky Bird 2, Unit No. 4X506 and 5V514A, Terminal 1, Hong Kong International Airport, Chek Lap Kok, Lantau Island, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 5, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 25, 2021. If persons subject to compulsory testing have previously undergone testing between June 21 and June 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

B. Schools within the specified area in Tai Po

(Persons who have completed a COVID-19 vaccination course (see note) would be taken to have complied with the requirements set out in the compulsory testing notice)

1. Any person who had been present at any of the below specified premises for more than two hours at any time during the period from June 10 to June 23, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by June 25, 2021. If persons subject to compulsory testing who had been present at the specified premises

- (1) to (5) choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by June 27, 2021. If persons subject to compulsory testing have previously undergone testing between June 21 and June 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

 - (4) Zebedee International Preschool, Wing A & Wing B, G/F, Yat Wing House, Yat Nga Court, Tai Po, New Territories, Hong Kong
 - (5) Yan Oi Tong Mrs Augusta Cheung Kindergarten Cum Nursery, 3/F, Neighbourhood Community Centre, Wan Tau Tong Estate, Tai Po, New Territories, Hong Kong
 - (6) Po Leung Kuk Tin Ka Ping Primary School, Wan Tau Tong Estate, Area 6, Tai Po, New Territories, Hong Kong
 - (7) Yan Chai Hospital Choi Hin To Primary School, Wan Tau Tong Estate, Area 6, Tai Po, New Territories, Hong Kong

C. Others

(Persons who have completed a COVID-19 vaccination course (see note) would be taken to have complied with the requirements set out in the compulsory testing notice)

1. Any person who had been present at Tsung Tsin Primary School and Kindergarten (Kindergarten Section), 58 Tai Po Road, Sham Shui Po, Kowloon, Hong Kong for more than two hours at any time during the period from June 10 to June 23, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by June 25, 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by June 27, 2021. If persons subject to compulsory testing have previously undergone testing between June 21 and June 23, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Note: For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before June 11, 2021. For persons previously infected with

COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before June 11, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before June 11, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website
