

**Details of Compulsory Testing Notices
(Updated as at June 28, 2021)**

Date of announcement: June 26, 2021

1. Any person who had been present at Good Health Child Care Centre (Ma On Shan Campus), 1/F, Saddle Ridge Garden, 6 Kam Ying Road, Ma On Shan, New Territories, Hong Kong for more than two hours at any time during the period from June 13 to June 26, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by June 29, 2021. If persons subject to compulsory testing choose to undergo testing using the specimen bottles distributed by the Centre for Health Protection, they have to return the specimen bottles with the sample by July 1, 2021. If persons subject to compulsory testing have previously undergone testing between June 24 and June 26, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice. Persons who have completed a COVID-19 vaccination course¹ would be taken to have complied with the requirements set out in the compulsory testing notices.

Date of announcement: June 27, 2021

1. Any person who had been present at Uptown Plaza (only the shopping mall is included), 9 Nam Wan Road, Tai Po, New Territories, Hong Kong at any time on any day of June 3, June 9, June 12, June 13 or June 15 to June 23, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 30, 2021. If persons subject to compulsory testing have previously undergone testing between June 25 and June 27, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Tai Po Mega Mall Zone C, 8 & 10 On Pong Road, Tai Po, New Territories, Hong Kong at any time during the period from 12:00 noon to 4:00 p.m. on June 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 30, 2021. If persons subject to compulsory testing have previously undergone testing between June 25 and June 27, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

¹ For both the Sinovac COVID-19 vaccine (CoronaVac vaccine) and Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine), completion of the vaccination course in general means having received two doses of COVID-19 vaccine at least 14 days ago, i.e. having received the second dose of COVID-19 vaccine on or before June 15, 2021. For persons previously infected with COVID-19, they may be deemed to have completed the COVID-19 vaccination course after receiving one dose of Comirnaty vaccine or one dose of CoronaVac vaccine at least 14 days ago, i.e. having received one dose of COVID-19 vaccine on or before June 15, 2021. For persons who received COVID-19 vaccines in places outside of Hong Kong and have received the recommended dose(s) as stipulated in relevant guidelines at least 14 days ago, i.e. having received all of the recommended dose(s) of COVID-19 vaccine on or before June 15, 2021, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine, subject to the vaccine used being included on the list of vaccines recognised for this purpose as published on the Government's COVID-19 thematic website (www.coronavirus.gov.hk/pdf/list_of_recognised_covid19_vaccines.pdf).

3. Any person who had been present at Tai Po Mega Mall Zone D, 8 & 10 On Pong Road, Tai Po, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 24, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 30, 2021. If persons subject to compulsory testing have previously undergone testing between June 25 and June 27, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

4. Any person who had been present at Fortune Plaza (only the shopping mall is included), 4 On Chee Road, Tai Po, New Territories, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 22, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by June 30, 2021. If persons subject to compulsory testing have previously undergone testing between June 25 and June 27, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
