**Details of Compulsory Testing Notice**

1. Any person who had been present at House 2, 12A South Bay Road, Repulse Bay, Hong Kong at any time during the period from June 9 to July 1, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by July 3, 2021. If persons subject to compulsory testing have previously undergone testing between June 29 and July 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
2. Any person who had been present at Bridal Tea House Hotel, 6 Arthur Street, Yau Ma Tei, Kowloon, Hong Kong at any time on June 14, June 16, June 17, June 28, June 30 or July 1, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by July 3, 2021. If persons subject to compulsory testing have previously undergone testing between June 29 and July 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
3. Any person who had been present at Bluejay Residences, 95 Main Street Ap Lei Chau, Ap Lei Chau, Hong Kong at any time on June 9, June 10, June 13, June 19, June 21, June 22, June 23, June 24 or June 27, 2021 (including but not limited to full-time, part-time and relief staff, students and visitors), has to undergo testing by July 3, 2021. If persons subject to compulsory testing have previously undergone testing between June 29 and July 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
4. Any person who had been present at McDonald's, G/F, Shops 6A-6B, Site 4, Aberdeen Centre, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 30, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 3, 2021. If persons subject to compulsory testing have previously undergone testing between June 29 and July 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
5. Any person who had been present at Aberdeen Market, Aberdeen Municipal Services Building, 203 Aberdeen Main Road, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 3, 2021. If persons subject to compulsory testing have previously undergone testing between June 29 and July 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at PARKnSHOP SUPERSTORE, G/F, Aberdeen Centre, 13-23 Nam Ning Street, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 29, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 3, 2021. If persons subject to compulsory testing have previously undergone testing between June 29 and July 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Lai See Snack Shop, Shops 17-18, 6/F, Wah Fu (II) Commercial Complex, Aberdeen, Hong Kong at any time during the period from 12:00 noon to 6:00 p.m. on June 27, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 3, 2021. If persons subject to compulsory testing have previously undergone testing between June 29 and July 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Sea East Restaurant, Shop 2 of G/F and Shop 3 of 1/F, Command Tower, 145 Main Street Ap Lei Chau, Ap Lei Chau, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 20, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 3, 2021. If persons subject to compulsory testing have previously undergone testing between June 29 and July 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.

Any person who had been present at Golden Gate Restaurant, G/F, 16 Wu Pak Street, Aberdeen, Hong Kong at any time during the period from 9:00 a.m. to 12:00 noon on June 26, 2021 (including but not limited to full-time, part-time and relief staff and visitors), has to undergo testing by July 3, 2021. If persons subject to compulsory testing have previously undergone testing between June 29 and July 1, 2021, they would be taken to have complied with the requirements set out in the compulsory testing notice.
