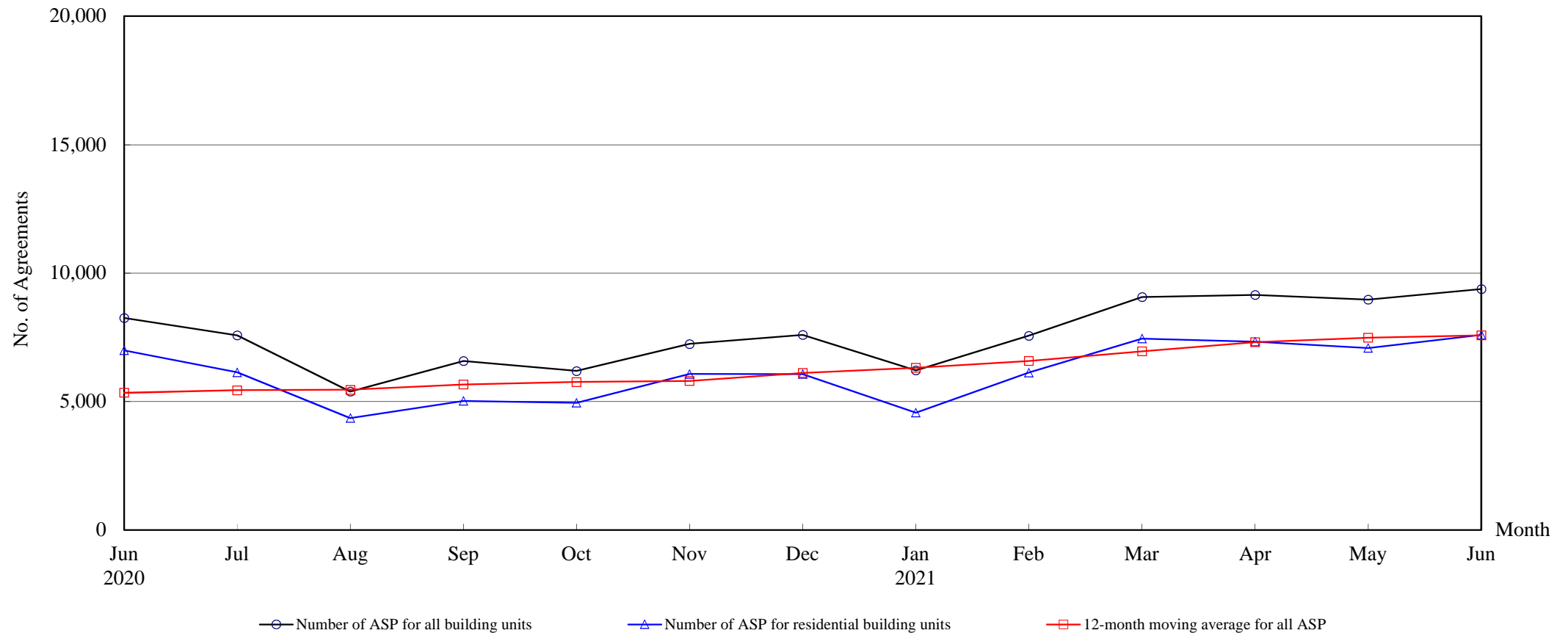

building units from June 2020 to June 2021



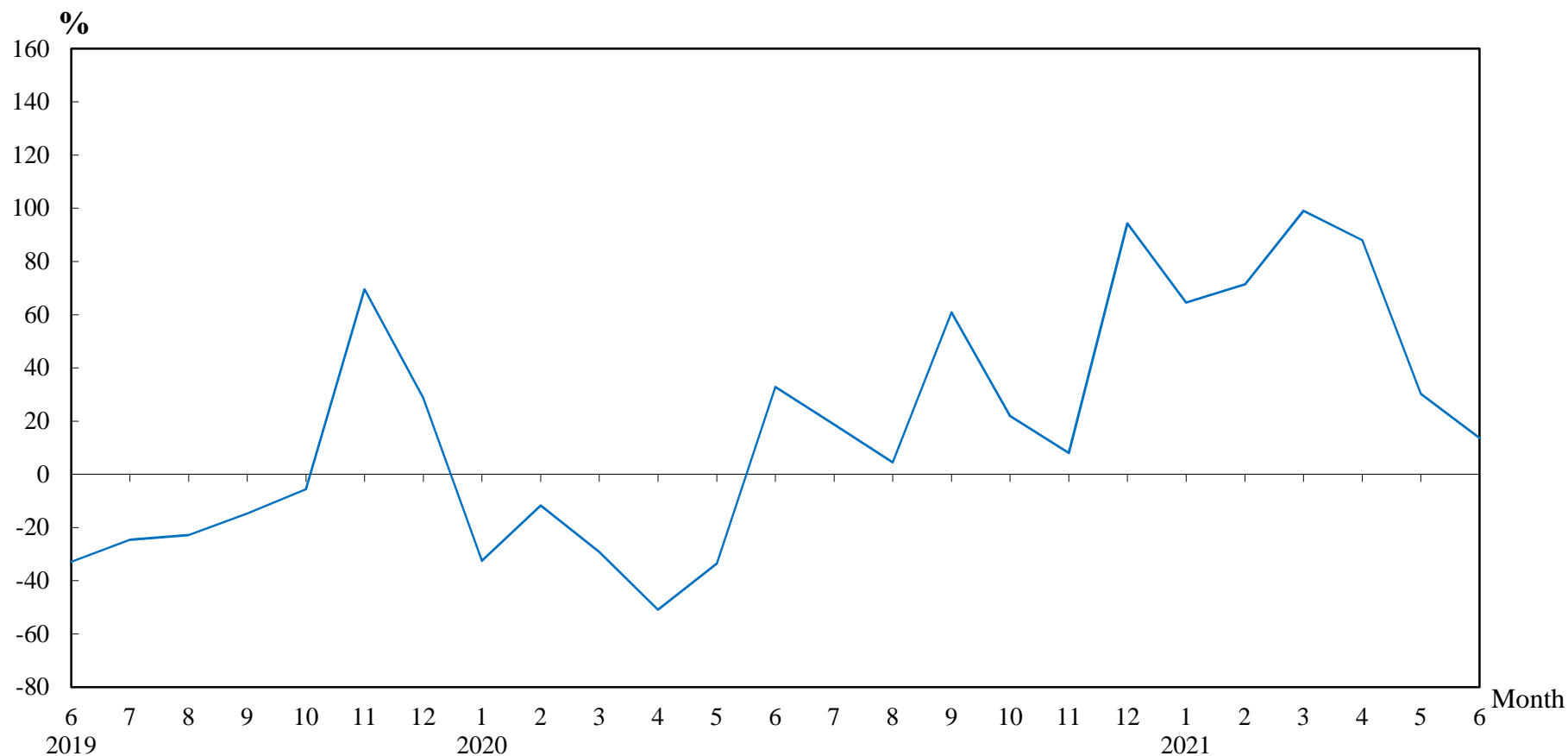
